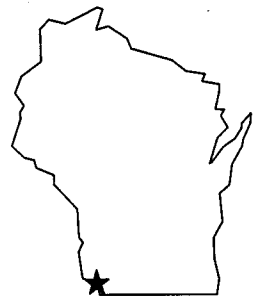

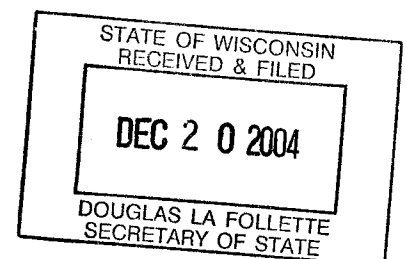
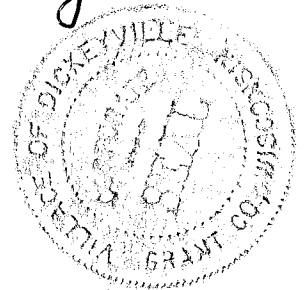

ORDINANCE CREATING SECTION 14.04 OF THE MUNICIPAL
CODE OF THE VILLAGE OF DICKEYVILLE

The Village Board of the Village of Dickeyville do ordain as follows:

Section 1. Section 14.04 of the Municipal Code of the Village of Dickeyville is hereby created as follows:

14.04 LAND ANNEXED. The following land, located in the Town of Paris, Grant County, Wisconsin, is hereby annexed to the Village of Dickeyville,



A parcel of land located in the NE¼ of the SE¼ and the NW¼ of the SE¼ of Section 22, T 2 N, R 2 W, Town of Paris, Grant County, Wisconsin described as follows:

Commencing at the East ¼ corner of Section 22, T 2 N, R 2 W; thence N89°44'53"W, 819.05' along the East - West ¼ line of said Section 22; thence S24°57'52"W, 4.31' to the centerline of McAdam Road and the Point of Beginning; thence continuing S24°57'52"W, 363.32'; thence N89°44'53"W, 523.08'; thence N24°56'49"E, 359.56' to a point on the centerline of McAdam Road; thence N89°53'01"E, 524.77' to the Point of Beginning.

This territory is annexed to Ward 1.

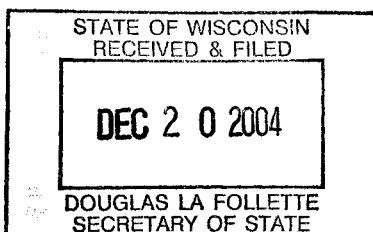
This territory is temporarily zoned R-1 Single-Family Residential District.

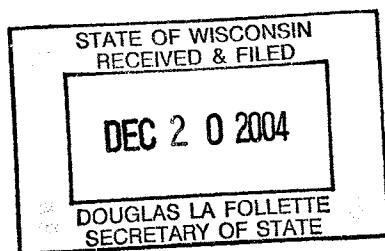


ANNEXATION PARCEL LEGAL DESCRIPTION :

ASSUMED TO BEAR N 89°44'53" W.

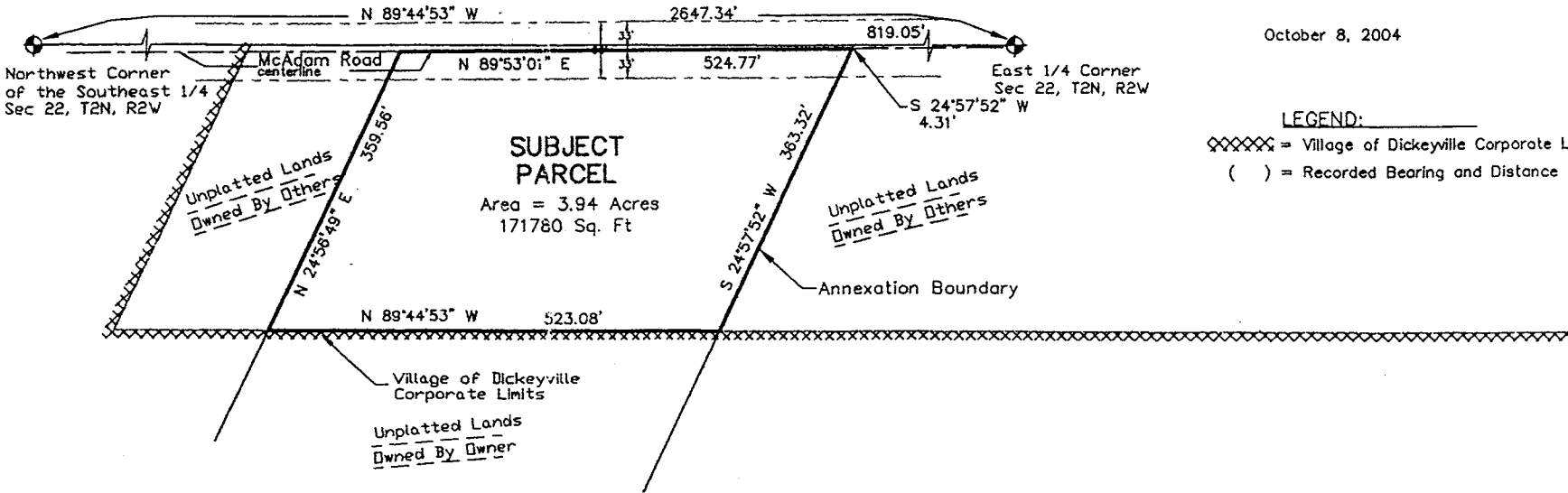

RESOLUTION


WHEREAS, the Village of Dickeyville intends to annex a parcel of land owned by Terry Bor Jane M Timmerman and formerly owned by the School District of Cuba City and located in the Town of Paris, Grant County, Wisconsin, and

WHEREAS, Section 66.0217(14), Wisconsin Statutes, requires that no territory may be annexed by a city or village unless the city or village pays annually to the town from which the property is annexed, for five years, an amount equal to the amount of property taxes that the town levied on the annexed territory,


NOW, THEREFORE, BE IT RESOLVED that, upon the annexation of said parcel of land from the Town of Paris, Grant County, Wisconsin, the Village of Dickeyville shall, annually, for a period of five years, beginning with the year 2004, pay to the Town of Paris, Grant County, Wisconsin, an amount equal to the property taxes levied on the land so annexed as shown by the tax roll of the Town of Paris, Grant County, Wisconsin, for the year 2004.
