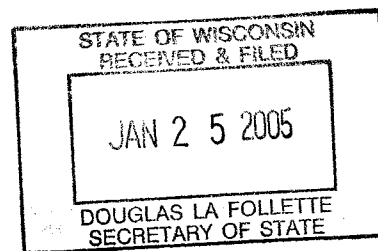

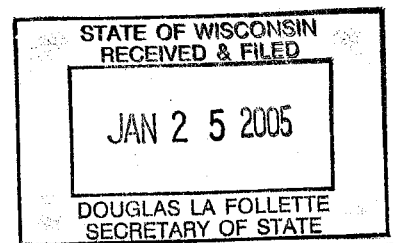

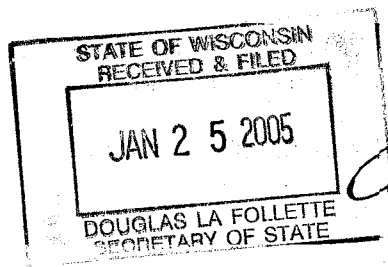

An ordinance to create Subsection (532) of Section 15.01 of the General Ordinances of the City of Madison entitled "City Boundaries" and being part of the chapter entitled "Aldermanic Districts and Wards".

WHEREAS, a petition for attachment with scale map attached was filed with the City Clerk of Madison on February 3, 2004, and has been presented to the Madison Common Council requesting attachment of the below-described territory to the City of Madison from the Town of Middleton; said petition having been signed by the owners of all of the land in the territory and notice of the proposed attachment having been given to the Town of Middleton; and

WHEREAS, investigation by the City of Madison discloses that as of this date the above representations are true, the Common Council now accepts the petition as sufficient and determines that the said attachment proceeding meets the requirements of the City of Madison and Town of Middleton Cooperative Plan approved pursuant to Section 66.0307, Wisconsin Statutes;

NOW, THEREFORE, the Common Council of the City of Madison do ordain as follows:

1. Subsection (532) of Section 15.01 of the Madison General Ordinances is hereby created to read as follows:

"15.01(532) - There is hereby attached to the 1st Aldermanic District, the City of Madison, Dane County, Wisconsin, the following described property:

A parcel of land located in the NE ¼ of the SW ¼ of Section 25, T7N, R8E, Town of Middleton, Dane County, Wisconsin more particularly described as follows:

Commencing at the Southwest corner of said Section 25; thence N1°08'08"E along the westerly line of said Section 25, 2410.19 feet; thence N88° 37'15"E, along the extension of the southerly right of way and on the southerly right of way of U.S. Highway 12 and 14 as designated in Wisconsin State Highway Commission Project No. T04-2 (34); 1389.88 feet to the point of beginning.

Thence continue N88°37'15"E along said southerly right of way 277.92 feet to the northwest corner of a property described in Volume 9304 of Deeds on page 49, said point is also on the existing boundary of the City of Madison; thence S1°07'28"W, (also recorded as S1° 07'57"W) along the west line of said property and the existing boundary of the City of Madison 376.15 feet to a point on the north right of way line of Seybold Road; thence N88° 35'39"E, 49.67 feet on said north right of way line; thence S1°08'08"W, 60.00 feet to a point on the southerly right of way line of Seybold Road; thence S88°35'15"W along said southerly right of way 327.24 feet; thence N1°04'15"E 436.31 feet to the point of beginning. This parcel contains 2.84 acres."

2. Subsection (130) of Section 15.02 entitled "Wards and Ward Boundaries" of the Madison General Ordinances is created to read as follows:

"(130) Ward 130. Commencing at the Southwest corner of Section 25 T7N, R8E, Town of Middleton, Dane County, Wisconsin; thence N1°08'08"E along the westerly line of said Section 25, 2410.19 feet; thence N88°37'15"E, along the extension of the southerly right of way and on the southerly right of way of U.S. Highway 12 and 14 as designated in Wisconsin State Highway commission Project No. T04-2 (34); 1389.88 feet to the point of beginning.

Thence continue N88°37'15"E along said southerly right of way 277.92 feet to the northwest corner of a property described in Volume 9304 of Deeds on page 49; thence S1°07'28"W, (also recorded as S1°07'57"W) along the west line of said property 376.15 feet to a point on the north right of way line of Seybold Road; thence N88°35'39"E, 49.67 feet on said north right of way line; thence S1°08'08" W, 60.00 feet to a point on the southerly right of way line of Seybold Road; thence S88°35'15" W along said southerly right of way 327.24 feet; thence N1° 04'15"E 436.31 feet to the point of beginning. Polling location at Madison Ice Arena, 725 Forward Drive."

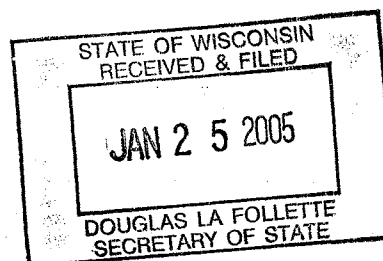
3. Subsection (1) entitled "First Aldermanic District" of Section 15.02 entitled "Wards and Ward Boundaries" of the Madison General Ordinances is hereby amended to read as follows:

"(1) First Aldermanic District. Wards 95, 96, 97, 98, 99, 107, 114, 121, 122, 123, 124, 125, 126, and 128, and 130."

4. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.

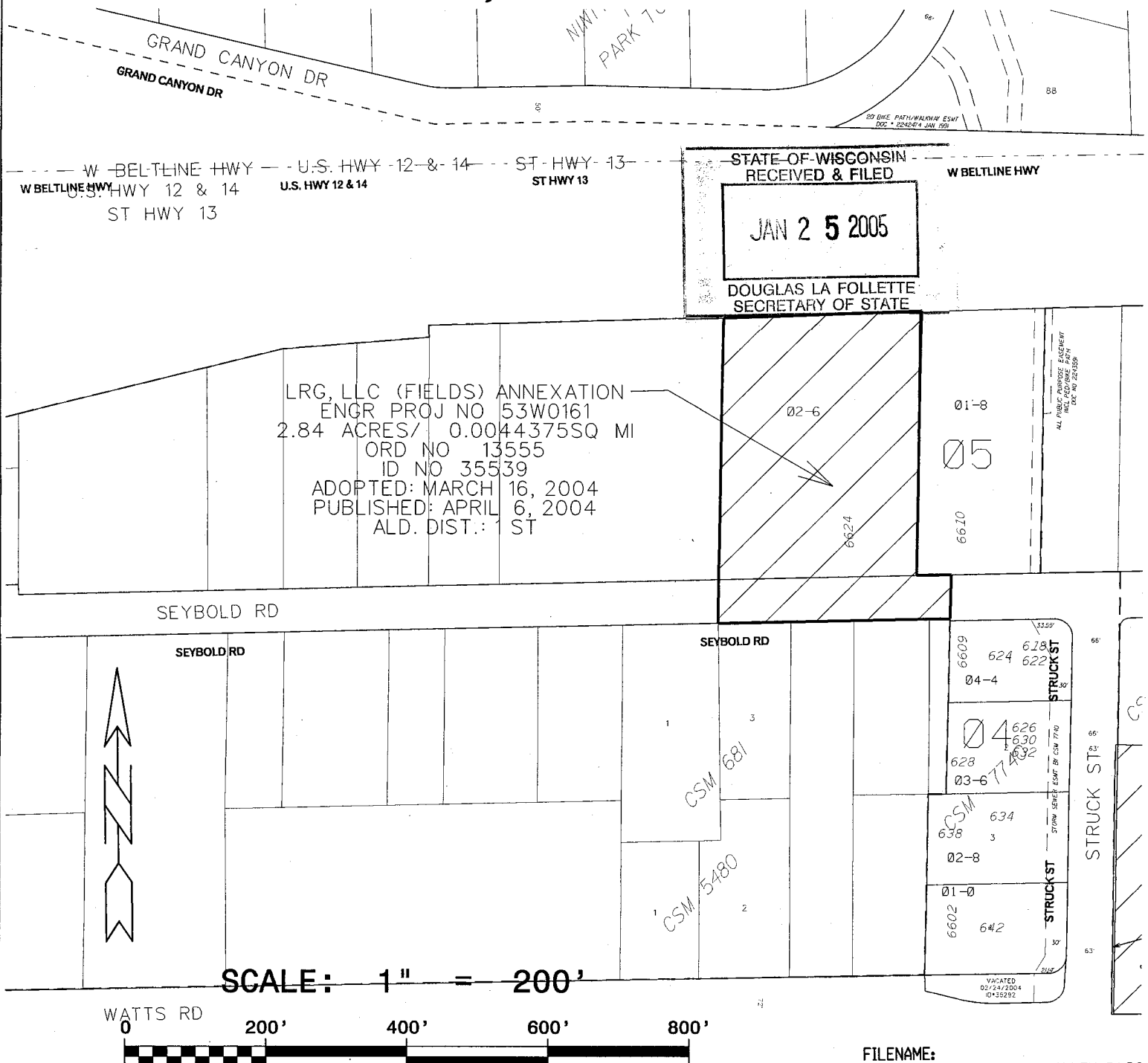
