VILLAGE OF SPRING VALLEY ORDINANCE NO. 2-2-05 DIRECTLY ANNEXING CERTAIN PROPERTIES AS DESCRIBED BELOW TO THE VILLAGE OF SPRING VALLEY, PIERCE COUNTY, WISCONSIN, A WISCONSIN MUNICIPAL CORPORATION

WHEREAS, a Petition for the Direct Annexation to the Village of Spring Valley, Pierce County, Wisconsin of those properties as hereinafter described was duly and properly presented to the Village Board for the Village of Spring Valley, Wisconsin at a Special Meeting on the Tenth day of January, 2005, all pursuant to Wis. Stats. sec. 66.021, and

WHEREAS, said Petition as referred to herein having fully complied with the requirements of Wis. Stats. sec. 66.021, and

WHEREAS, there being no objection to said proposed annexation made under or pursuant to Wis. Stats. sec. 66.021 as referred to herein, and
