

ORDINANCE 955

AN ORDINANCE ANNEXING TERRITORY TO THE CITY OF CLINTONVILLE FROM THE TOWN OF LARRABEE, WAUPACA COUNTY, WISCONSIN.

Section One: <u>Territory Annexed</u>. Pursuant to the authority granted by Section 66.021, Wis. Stats., the following described territory in the Town of Larrabee, Waupaca County, Wisconsin, is hereby annexed to the City of Clintonville:

Section Two: (See attached Exhibit A - Legal description and map).

Section Three: Zoning Classification: Parcel shall be zoned I-1 – Industrial District

Section Four: <u>Ward Designation</u>: The territory described in Section One and Section Two of this ordinance is hereby made a part of the Second Ward of the First Aldermanic District of the City of Clintonville, subject to the ordinances, rules and regulations of the City of Clintonville governing wards and districts.

Section Five: <u>Severability</u>. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstance is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or application of this ordinance which can be effected without the invalid or unconstitutional provision or application.

Section Six: <u>Effective Date</u>. This ordinance shall take effect upon passage and publication.


