ORDINANCE NO. 1230

AN ORDINANCE TO ATTACH TOWN OF DODGEVILLE TERRITORY TO THE CITY OF DODGEVILLE, IOWA COUNTY, WISCONSIN

WHEREAS, a petition was filed with the City Clerk for direct annexation, in accordance with Section 66.0217 (2), Wis. Stats.; of the Town of Dodgeville territory described in Exhibit "A" attached hereto; and

WHEREAS, a copy of the Petition for Direct Annexation and a scale map of the territory proposed to be annexed were mailed to the Clerk of the Town of Dodgeville and the Wisconsin Bureau of Land Use, Department of Administration as required by subsection 66.021 (11) and (12), Stats., as evidenced by the Affidavit of Mailing on file with the City Clerk; and

WHEREAS, the advice of the State of Wisconsin Bureau of Land Use, Department of Administration concerning this annexation has been considered; and

WHEREAS, the Petition was referred to the City Plan Commission for recommendation concerning the Petitioners' request that said territory be assigned a temporary zoning classification of R-1 Single and Two Family Residential District and the Plan Commission's recommendation for temporary zoning classification is on file; and

WHEREAS, said Petition is signed by all the owners of the territory to be annexed and there are no residents residing therein; and

WHEREAS, said territory is adjacent to the boundaries of the City of Dodgeville; and

WHEREAS, said territory is adjacent to the boundaries of the existing First Ward of the City of Dodgeville;

NOW THEREFORE the Common Council of the City of Dodgeville, Iowa County, Wisconsin, do ordain as follows:

SECTION I.

That there is hereby annexed to the City of Dodgeville, the property described in Exhibit "A" attached hereto.

STATE OF WISCONSIN

SECTION II.

That the territory is hereby annexed to the First Ward.

SECTION III.

That the territory hereby annexed is assigned a temporary zoning classification of R-1 Single and

Two Family Residential District as recommended by the City Plan Commission.

SECTION IV.

That the annexation shall be effective upon the enactment of this Annexation Ordinance by a two-thirds (2/3) vote of the members of the Common Council and the publication of this Ordinance.

SECTION V.

This ordinance shall be	n force following its	adoption and publication	as provided b	y law.




