I, Edwin R. Abendroth, registered land surveyor, hereby certify that I have surveyed and mapped by the order of, Taylor Investment Corporation, that part of Government Lot 6, Section 21, Township 35 North, Range 6 East, Town of Bradley, Lincoln County, Wisconsin, described as follows: Commencing at the southwest corner of said Section 21; thence N89°21'06"E, 124.36 feet to the point of beginning: thence on the arc of a curve whose chord bears N2°23'59"E, 152.79 feet: thence MI°06'49"E, 510.37 feet; thence N79°14'27"E, 972.95 feet to a point which is 30 feet from the water of the Jersey City Flowage; thence on a meander line along said flowage, S59°39'10"E, 299.52 feet; thence S16°55'28"E, 150.80 feet; thence \$45°08'16"W, 385.20 feet; thence S30°50'57"W, 286.63 feet to an iron pipe which is 136 feet, more or less, from the water's edge of said flowage and the end of said meander line; thence S89°21'06"W, 880.45 feet to the point of beginning. Including all lands lying between the above described meander line and the water's edge of the Jersey City Flowage.

#### CITY OF TOMAHAWK SPECIAL ORDINANCE 2005-<u>1</u> (ANNEXATION) A SPECIAL ORDINANCE ANNEXING TERRITORY TO THE CITY OF TOMAHAWK, LINCOLN COUNTY, WI

The Common Council of the City of Tomahawk ordains as follows:

#### **SECTION 1**

<u>Territory Annexed</u>: In accordance with Section 66.0217(2) of the Wisconsin Statutes, and the petition for a direct annexation filed with the City Clerk by all of the owners and electors of the land in the area to be annexed, the following described territory in the Town of Bradley, Lincoln County, Wisconsin, is annexed to the City of Tomahawk:

Parcel Six (6), Certified Survey Map No. 632, being part of Government Lot Six (6), Section Twenty-one (21), Township Thirtyfive (35) North, Range Six (6) East, Town of Bradley, Lincoln County, Wisconsin.

The current population of such territory is zero (0).

#### **SECTION 2**

**Effect of Annexation**: From and after the adoption date of this ordinance, the territory described in Section 1 shall be a part of the City of Tomahawk for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules, and regulations governing the City of Tomahawk.

#### **SECTION 3**

<u>Ward Designation</u>: The territory described in Section 1 of this ordinance is hereby designated as part of the <u>6th</u> Ward of the City of Tomahawk, subject to ordinances, rules, and regulations of the city governing wards.

#### **SECTION 4**

**Zoning**: The territory being annexed to the City of Tomahawk shall become part of the R-2 zoning district.

#### **SECTION 5**

<u>Severability</u>: If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstance is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or application of this ordinance which can be given effect without the invalid or unconstitutional provisions or application.
