ANNEXATION ORDINANCE 06/28/05

-To annex Real Estate (former Perry Property adjacent the WWTP, currently in the Town of Bashaw) to the City of Spooner Pursuant to §66.0217(2), Wis. Stats.-

THE COMMON COUNCIL OF THE CITY OF SPOONER DOES HEREBY ORDAIN AS FOLLOWS:

Section One: That the City of Spooner does hereby annex to the City that real estate described in the Petition, Exhibit "A", attached hereto and incorporated herein by reference, a Petition having been filed with the City Clerk which, consistent with §66.0217(2), Wis. Stats., was signed by all of the owners thereof, there being no electors residing thereupon, thus qualifying the Petition for consideration by the common Council as a Petition for Direct Annexation by unanimous approval under §66.0217(2), Wis. Stats.

Section Two: That this Ordinance shall take effect upon its adoption, in accord with §66.0217(2) and (8), Wis. Stats.

Section Three: That in accord with §66.0217(8)(a), Wis. Stats., upon annexation, the described real estate shall be temporarily zoned Agricultural until permanent zoning is recommended to the Common Council by the Planning Commission and is adopted by the Common Council. To this effect, the matter of the zoning of the subject real estate is referred to the Planning Commission for its recommendation, to be rendered to the Common Council within ninety days (90) of the date of adoption of this Ordinance.

Section Four: That this Ordinance need not be codified.


