AN ORDINANCE ANNEXING CERTAIN LANDS OF THE TOWN OF WAUKESHA TO THE CITY OF WAUKESHA, WISCONSIN

THE COMMON COUNCIL OF THE CITY OF WAUKESHA DO ORDAIN AS FOLLOWS:

SECTION I. In accordance with Section 66.021 of the Wisconsin Statutes and petition for annexation filed with the City Clerk on the 28th day of February, 2005, the following described territory in the Town of Waukesha, Waukesha County, Wisconsin is annexed to the City of Waukesha:

All that part of the Northwest 1/4, Northeast 1/4, Southwest 1/4 and Southeast 1/4 of the Northwest 1/4 of Section 6, Town 6 North, Range 19 East, in the Town of Waukesha, Waukesha County, Wisconsin, now being more particularly bounded and described as follows:

Commencing at the Northwest corner of the said Northwest 1/4 Section, said point being the place of beginning of lands hereinafter described;

Thence South 00° 38' 29" West and along the West line of the said Northwest 1/4 Section, 2655.37 feet to the Southwest corner of the said Northwest 1/4 Section; Thence North 87° 24' 06" East and along the South line of the said Northwest 1/4 Section, 1973.36 feet to a point; Thence North 00° 18' 04" West and parallel to the East line of the said Northwest 1/4 Section, 2611.26 feet to a point on the North line of the said Northwest 1/4 Section; Thence South 88° 38' 56" West and along the said North line of the said Northwest 1/4 Section, 1928.42 feet to the point of beginning of this description.

Said Parcel contains 5,133,201 Square Feet (or 117.8421 Acres) of land, more or less.

SECTION II. The above shall be zoned pursuant to the authority granted in Section 66.021(7) of the Wisconsin Statutes as T-1, Temporary Zoning District.

SECTION III. The annexed territory is hereby made a part of the 13th Aldermanic District, and is in the 47th Ward of the City of Waukesha and is annexed for all municipal purposes including annexation for school purposes and is hereby made a part of the School District of Waukesha, and subject to laws governing the same.

SECTION IV. The City limits of the City of Waukesha, Wisconsin are hereby changed and enlarged as so to include the real estate described in Section I of this ordinance and the official map is amended to include said real estate.

SECTION V. Should any section, paragraph, sentence, clause or phrase of this ordinance be declared unconstitutional or invalid for any reason, the remainder shall not be affected thereby.

SECTION VI. All ordinances or parts of ordinances inconsistent with or contravening the provisions of this ordinance are hereby repealed.

SECTION VII. This ordinance shall be in full force and effect from and after its passage and publication by law.
