### **ORDINANCE NO. 2005-2**

AN ORDINANCE ANNEXING TERRITORY TO THE VILLAGE OF MONTFORT, GRANT AND IOWA COUNTIES, WISCONSIN, AND ESTABLISHING TEMPORARY ZONING THEREFORE.

THE VILLAGE BOARD OF THE VILLAGE OF MONTFORT, GRANT AND IOWA COUNTIES, WISCONSIN, DO ORDAIN AS FOLLOWS:

### SECTION I: TERRITORY ANNEXED

In accordance with Section 66.0217, Wisconsin Statutes, and the petition for direct unanimous annexation made pursuant to Wisconsin Statute sec. 66.0217(2), filed with the Clerk of the Village of Montfort, Grant and Iowa Counties, Wisconsin, signed by all the owners of real property within such territory and all electors residing with said territory and all jurisdictional and procedural requirements having been met, the following described territory in the Town of Wingville, Grant County, Wisconsin, is hereby annexed to the Village of Montfort, Grant and Iowa Counties, Wisconsin, to-wit:

See attached Exhibit A.

### SECTION II: EFFECT OF ANNEXANTION

From and after the date of this ordinance the territory described in SECTION I shall be part of the Village of Montfort, Grant and Iowa Counties, Wisconsin, for any and all purposes provided by law and all persons coming or residing within that territory shall be subject to all ordinances, rules and regulations governing the Village of Montfort, Grant and Iowa Counties, Wisconsin.

### SECTION III: TEMPORARY ZONING DISTRICT CLASSIFICATION

Until such time as a permanent zoning classification or classifications may be established pursuant to the requirements of the Municipal Code of the Village, the above-described property shall be temporarily classified as being zoned as a part of the (R-2) Multi Family Residential District.

### SECTION IV: SEVERABILITY

If any part of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstance is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or application of this ordinance which can be given effect without the invalid or unconstitutional provision or application.



### **DESCRIPTION:**

Part of the Southeast Quarter (SE 1/4) of the Southwest Quarter (SW 1/4) of Section Twenty-Four (24), Town Six (6) North, Range One (1) West of the 4th P.M., Wingville Township, Grant County, Wisconsin, said parcel being described as follows:

Commencing at the South Quarter (S 1/4) corner of said Section 24, said corner being the point of beginning;

Thence North 89° 52' 37" West 104.50' along the South line of said Section 24; Thence North 00° 32' 20" East 191.27' to a point on the centerline of Route 66; Thence South 83° 00' 54" East 103.09' along the centerline of Route 66; Thence South 00° 07' 08" East 178.95' along the North-South Quarter line of said Section 24 to the point of beginning, containing 0.44 acres, more or less, and being subject to any and all easements of record and/or usage.
