Galeazzi, City Clerk of the City of Menasha, Winnebago and Calumet Counties, State of Wisconsin, **do hereby certify** that the following described property was annexed from the City of Appleton, County of Winnebago, to the City of Menasha, County of Winnebago pursuant to Section 66.021(12) of the Wisconsin Statutes by an ordinance (Ordinance O-27-05) adopted by the Common Council of the City of Menasha at a regular meeting held November 21, 2005.

That part of the Southeast ¼ of the Southeast ¼ of Section One (1), Township Twenty (20) North of Range Seventeen (17) East in the Town of Menasha and now in the City of Appleton, Winnebago County, Wisconsin, described as follows, viz: Commencing at the Southeast corner of said Section; thence North 89°17" West along the South line of said Section, 330.00 feet; thence North 0°27" West, parallel with the East line of said Section 165.00 feet to an iron pipe; thence South 89°17" East, parallel with the South line of said Section 330.00 feet to the East line of said Section; thence South 0°27" East along the East line of said Section, 165.00 feet to the place of beginning, excepting there from that portion thereof heretofore conveyed by Deed recorded as Document No. 588080.

AN ORDINANCE RELATING TO THE ANNEXATION OF CERTAIN PROPERTY TO THE CITYOF MENASHA, WISCONSIN (BJ Clancy Annexation)

Introduced by Mayor Joseph F. Laux

The Common Council of the City of Menasha does ordain as follows:

SECTION 1: Territory Annexed. (Direct Annexation) In accordance with Sec. 66.0217(2) Wis. Stats., and the Petition for Direct Annexation filed with the City Clerk on the 21st day of September, 2005, signed by the all of the owners of land in the territory, the following described territory in the City of Appleton, Winnebago County Wisconsin, is annexed to the City of Menasha, Winnebago County, Wisconsin.

## Legal description:

That part of the Southeast ¼ of the Southeast ¼ of Section One (1), Township Twenty (20) North of Range Seventeen (17) East in the Town of Menasha and now in the City of Appleton, Winnebago County, Wisconsin, described as follows, viz: Commencing at the Southeast corner of said Section; thence North 89°17" West along the South line of said Section, 330.00 feet; thence North 0°27" West, parallel with the East line of said Section 165.00 feet to an iron pipe; thence South 89°17" East, parallel with the South line of said Section 330.00 feet to the East line of said Section; thence South 0°27" East along the East line of said Section, 165.00 feet to the place of beginning, excepting there from that portion thereof heretofore conveyed by Deed recorded as Document No. 588080...

SECTION 2: Effect of Annexation. From and after the date of this Ordinance, the territory described in Section 1 shall be a part of the City of Menasha for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of Menasha.

SECTION 3: Pending the recommendation of the Planning Commission, the temporary classifications and regulations for the zoning of the annexed area is designated C-1, General Commercial.

SECTION 4: Aldermanic District Designation. The territory described in Section 1 of this Ordinance is hereby made a part of Aldermanic District 8, Ward 18, subject to the ordinances, rules and regulations of the City governing wards and aldermanic districts.

SECTION 5: Severability. If any provision of this Ordinance is invalid or unconstitutional, or if the application of this Ordinance to any person or circumstance is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this Ordinance which can be given effect without the invalid or unconstitutional provision or application.

SECTION 6: This Ordinance shall become effective upon its passage and publication as provided by law.


