AN ORDINANCE ANNEXING TERRITORY FROM THE TOWN OF POUND TO THE VILLAGE OF COLEMAN, MARINETTE COUNTY, WISCONSIN

Property Owner: Ross Prior

WHEREAS, a Petition has been filed with the Clerk of the Village of Coleman requesting the annexation of the hereinafter described territory heretofore located in the Town of Pound, Marinette County, Wisconsin to the Village of Coleman, Marinette County, Wisconsin, pursuant to Section 66.0217(2), Wis. Stats; and

WHEREAS, such matter was referred to the Village Board for review, the Village Board recommending such approval, and finding that the territory is contiguous and that the annexation is not contrary to the public interest; and

WHEREAS, the Village Board finds that the hereinafter described territory is contiguous to the Village of Coleman, that the Petition for Annexation herein is a Petition for direct annexation filed pursuant to Section 66.0217(2), Wis.
