ORDINANCE NO. 1607-06 (An Ordinance Detaching Territory From The City of Reedsburg, Wisconsin, Ralph & Evalyn Bindl, owners)

The City of Reedsburg, Sauk County, Wisconsin, does hereby ordain as follows:

SECTION 1: PURPOSE

The purpose of this ordinance is to detach property pursuant to Wis. Stat. sec. 66.0227.

SECTION II: PROVISION AMENDED

The official map for the City of Reedsburg as set forth in the City of Reedsburg is hereby permanently amended so as to detach the territory listed below

SECTION III: TERRITORY DETACHED.

In accordance with Wis. Stat § 66 0227 and the petition for detachment filed with the City Clerk on the 26th day of January, 2006, signed by the sole owner of land in the territory, the following described territory in the City of Reedsburg, Wisconsin is detached from the City of Reedsburg to the Town of Reedsburg.

A parcel of land located in the Southwest Quarter of the Southwest Quarter, and the Southeast Quarter of the Southwest Quarter of Section 15, T12N, R4E, City of Reedsburg, Sauk County, Wisconsin, described as follows: Commencing at the Southwest Corner of said Section 15; thence Northerly, along the west line of said Section 15, 1,099 feet more or less, to the Southwest corner of Sauk County Certified Survey Map No. 1520; Thence Easterly, 140 feet more or less, along the southerly line of said Certified Survey Map No. 1520; Thence Northerly, 221 feet more or less, along the easterly line of said Certified Survey Map No. 1520; Thence Easterly, 1,933 feet more or less, along the northerly lines of the Southwest Quarter of the Southwest Quarter, and the Southeast Quarter of the Southwest Quarter, to a point which is thirty-six rods westerly of the northeast corner of the Southeast Quarter of the Southwest Quarter, said Section 15; Thence Southerly, 650 feet more or less, to the north line of the south one-half of the south one-half of the Southwest Quarter of Section 15; Thence Westerly, 620 feet more or less, along the north line of the south one-half of the south one-half of the Southwest Quarter of Section 15, to the centerline of the creek; Thence Southwesterly, 132 feet more or less, along the centerline of the creek to the east line of the Southwest Quarter of the Southwest Quarter of Section 15; Thence Southerly, 576 feet more or less, along the east line of the Southwest Quarter of the Southwest Quarter of Section 15, to the south line of said Section 15; Thence Westerly along said south line, 1,322 feet more or less, to the Southwest Corner of Section 15, being the point of beginning. Containing 50.5 acres more or less.

This detachment has a zero (0) decrease on the City's population.

SECTION IV: VALIDITY.

Should any section, clause or provision of the ordinance be declared by the courts to be invalid, the same shall not affect the validity of the ordinance as a whole or any part thereof, other than the part so declared to be

SECTION V: CONFLICTING PROVISIONS REPEALED

All ordinances in conflict with any provisions of the ordinance are hereby repealed

SECTION VI: EFFECTIVE DATE.

This ordinance shall be in force from and after its introduction and publication as provided by statute






