ORDINANCE 201 ORDINANCE ANNEXING TERRITORY TO THE CITY OF ARCADIA, WISCONSIN

The Common Council of the City of Arcadia, Wisconsin do ordain as follows:

SECTION ONE: TERRITORY ANNEXED: in accordance with s. 66.0217 of the Wisconsin Statutes, and the Petition for Direct Annexation by unanimous approval filed with the City Clerk on the 24th day of May, 2006, the Exhibit A territory in the Town of Arcadia, Trempealeau County, Wisconsin, is annexed to the City of Arcadia, Wisconsin, a municipal corporation, located within the confines of the County of Trempealeau and State of Wisconsin.

<u>SECTION TWO:</u> <u>SUFFICIENCY OF PETITION</u>. The City Council of the City of Arcadia, Wisconsin, determines that the Petition for Annexation of the above-described territory is a sufficient and legal petition conforming with the requirement of s. 66.0217 of the Wisconsin Statutes.

<u>SECTION THREE: EFFECTIVE ANNEXATION</u>. From and after the date of this ordinance, the territory described in SECTION ONE shall be a part of the City of Arcadia for any and all purposes provided by law and all persons coming in or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of Arcadia.

SECTION FOUR: WARD. The territory described in SECTION ONE is hereby made a part of the First Ward.

SECTION FIVE: SEVERABILITY. If any provision of this Ordinance is invalid or unconstitutional, or if the application of this Ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this Ordinance which can be given effect without the invalid or unconstitutional provision or application.

<u>SECTION SIX:</u> <u>ZONING.</u> Pursuant to s. 66.0217(8)(a) of the Wisconsin Statutes, and consistent with the recommendation of the City Plan Commission, the territory described in SECTION ONE is hereby zoned Industrial.

<u>SECTION SEVEN: EFFECTIVE DATE</u>. This ordinance shall take effect upon passage and publication as provided by law.
