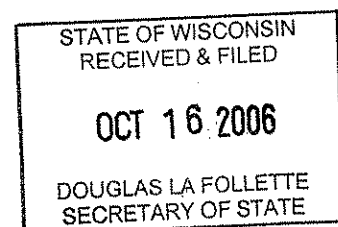

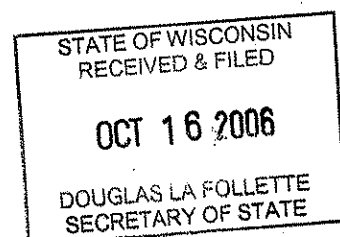

PETITION FOR ANNEXATION


Pursuant to Section 66.0217(2) of the Wisconsin Statutes, the undersigned being all of the owners of the real property in the described territory and all of the electors residing in said territory do hereby petition the Village of Arena into its corporate limits of the following described real estate presently in the Town of Arena, Iowa County, Wisconsin.

Being part of the East 1/2 of the SE1/4 of Section 16 and the West 1/2 of the SW1/4 of Section 15, all in T8N, R5E, Town of Arena, Iowa County, Wisconsin.

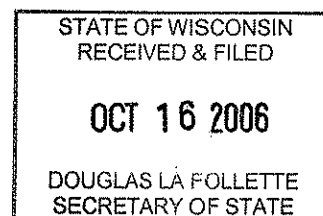

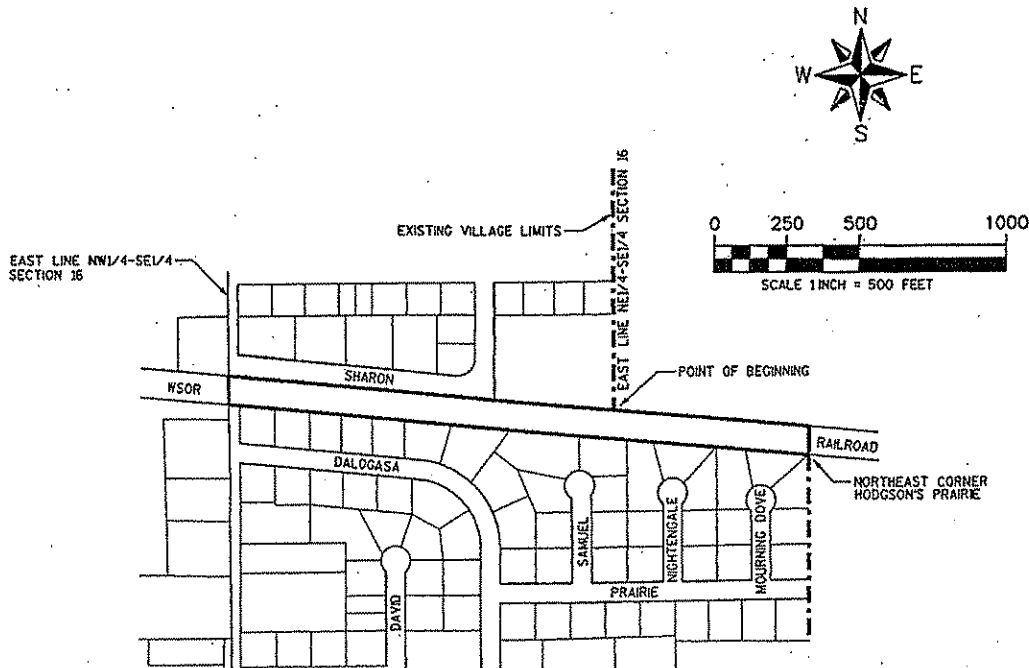
