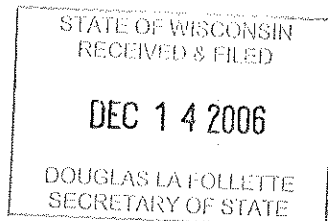

ORDINANCE 2006-17

ORDINANCE ANNEXING TERRITORY TO THE VILLAGE OF NORTH FOND DU LAC (Hopp)

The Village Board of North Fond du Lac do ordain as follows:

SECTION 1 – Territory Annexed. In accordance with sec. 66.0217 of the Wisconsin Statutes and the petition for direct unanimous annexation filed with the Village Clerk on the 4th of October, 2006, signed by all of electors residing in the territory equal to all of the votes cast in the territory at the gubernatorial election and owners of all of the land in the following described territory in the Town of Fond du Lac, Fond du Lac County, is annexed to the Village of North Fond du Lac, Wisconsin.

Commencing at the Northwest corner of the West 32 acres of the Northwest quarter, Northeast quarter of Section 5, Township 15 North, Range 17 East, Town of Fond du Lac, Fond du Lac County, Wisconsin, thence East along the North line of said Northwest quarter of the Northeast quarter and along the center line of Road, 100.00 feet to the place of beginning for the description of this parcel; thence continuing East along said North line and said center line, 100.00 feet; thence South and parallel with the West line of said Northwest quarter of the Northeast quarter, 250.8 feet, thence West and parallel with the center line of the Road, 100.00 feet; thence North, 250.8 feet to the place of the beginning and subject to the rights of the public for highway purposes over the North 33.0 feet of the above described property.

The current population of such territory is 6.

SECTION 2 – Effect of Annexation. From and after the date on this ordinance the territory described in section 1 shall be part of the Village of North Fond du Lac for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the Village of North Fond du Lac.

ORDINANCE 2006-17

SECTION 3 – Zoning Classification. The Territory annexed to the Village of North Fond du Lac by this ordinance is zoned as follows, pursuant to sec. 66.23(7)(d) of Wisconsin Statutes: R-7 Annexed.

SECTION 4 – Severability. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not effect the other provisions or applications of this ordinance which can be given without the invalid or unconstitutional provision or applications.

SECTION 5. This ordinance shall take effect and be in full force from and after its passage and posting.

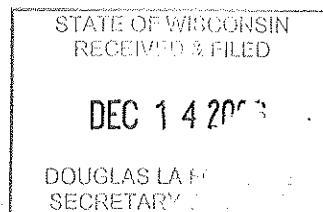



