



The Common Council of the City of Appleton does ordain as follows:

Section 1. <u>Territory Annexed</u>. In accordance with Sec. 66.0217 of the *Wisconsin Statutes* for 2003-2004 and the *Unanimous Petition for Direct Annexation* filed with the City Clerk on November 1, 2006, the following described territory in the Town of Grand Chute, Outagamie County, Wisconsin, lying contiguous to the City of Appleton, is hereby annexed to the City of Appleton, Wisconsin:

Part of the Southwest Quarter (SW ¼) of the Southwest Quarter (SW ¼) of Section 5 and the Northwest Quarter (NW ¼) of the Northwest Quarter (NW ¼) of Section 8, Township Twenty-one (21) North, Range Eighteen (18) East, in the Town of Grand Chute, Outagamie County, Wisconsin, containing 40.95 Acres of land m/l and being further described by:

Commencing at the Southwest corner of said Section 5;

Thence N.00°02'25"W. 1325.97', along the West line of the SW ¼ of said Section 5, to the North line of the SW ¼ of the SW ¼ of said Section 5;

Thence S.88°34'11"E. 33.01', along the North line of the SW ¼ of the SW ¼ of said Section 5, to the East line of French Road and being the point of beginning.

Thence continue S.88°34'11"E. 1308.36' along the North line of the SW ¼ of the SW ¼ of said Section 5;

Thence S.00°07'17"W. 1242.06', along the East line of the SW ¼ of the SW ¼ of said Section 5, to the North line of C.T.H. "JJ";

Thence continue S.00°07'17"W. 125.02', along the East line of the SW ¼ of the SW ¼ of said Section 5, to the South line of said C.T.H. "JJ";

Thence N.88°51'39"W. 1270.73', along the South line of said C.T.H. "JJ";

Thence N.06°20'48"E. 120.50', to a point on the North line of C.T.H. "JJ";

Thence N.44°28'12"W. 67.17', along a vision corner to the East line of said French Road;

Thence N.00°02'25"W. 1206.78', along the East line of said French Road, to the point of beginning.

The current population of such territory is 0 people.

Section 2. <u>Effect of Annexation</u>. From and after the date of this ordinance, the territory described in Section 1 shall be a part of the City of Appleton for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules

and regulations governing the City of Appleton. The payments required by Wisconsin Statutes §66.0217(14) are hereby authorized.

Section 3. <u>Ward Designation</u>. The territory described in Section 1 of this ordinance is hereby made a part of the Sixtieth (60th) Ward, attached to the Thirteenth (13th) Aldermanic District of the City of Appleton, Outagamie County, subject to the ordinances, rules and regulations of the City governing Wards.

Section 4. Zoning Classification. The territory described in Section 1 is hereby zoned as follows, pursuant to Sec. 66.0217(7)(a), Stats. and Sec. 23.65(e), Appleton Municipal Code:

AG (Agricultural)

Section 5. Severability. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance, which can be given effect without the invalid or unconstitutional provision or application.

Section 6. Effective Date. This ordinance shall take effect upon passage and publication.
