# ORDINANCE PROVIDING FOR DIRECT ANNEXATION OF A PORTION OF THE TOWN OF BELGIUM, OZAUKEE COUNTY, WISCONSIN, TO THE VILLAGE OF BELGIUM, OZAUKEE COUNTY, WISCONSIN

**BE IT ORDAINED,** by the Village Board of the Village of Belgium, Ozaukee County, Wisconsin, as follows:

### Section 1. Territory Annexed.

In accordance with Sec. 66.0217 of the Wisconsin Statutes, and the petition for direct annexation filed with the Village Clerk on the 20<sup>th</sup> day of September, 2006, signed by all of the electors residing in the territory and the owners of all the real property in the territory, the following described territory in the Town of Belgium, Ozaukee County, Wisconsin, is annexed to the Village of Belgium, Ozaukee County, Wisconsin:

A part of the Southeast ¼ of the Northeast ¼ of Section 21, Township 12 North, Range 22 East, Town of Belgium, Ozaukee County, Wisconsin and more particularly described as follows: Beginning at the East ¼ corner of said Section 21; thence S. 88 degrees 29 minutes 49 seconds W., 1092.67 feet along the South line of the Northeast ¼ of said Section 21, thence N. 00 degree 00 minute 19 seconds W., 388.98 feet; thence N. 89 degrees 59 minutes 41 seconds E., 214.64 feet; thence S. 37 degrees 32 minutes 20 seconds E., 118.50 feet; thence N. 89 degrees 59 minutes 41 seconds E., 313.73 feet; thence S. 00 degree 00 minute 19 seconds E., 239.30 feet; thence N. 88 degrees 29 minutes 49 seconds E., 490.70 feet to the East line of the Northeast ¼ of said Section 21; thence S. 01 degree 43 minutes 24 seconds E., 40.00 feet along said East line to the Point of beginning.


