## **ORDINANCE NO. 07-0685**

AN ORDINANCE ANNEXING CERTAIN LANDS OF THE TOWN OF OCONOMOWOC TO THE CITY OF OCONOMOWOC, WISCONSIN (ROGER AND PATRICIA GARTZKE PROPERTY) STATE OF WISCONSIN RECEIVED & FILED

The Common Council of the City of Oconomowoc, Waukesha County,

Wisconsin, does ordain as follows:

SECTION 1. <u>TERRITORY ANNEXED</u>. In accordance with §66.0217 of the Wisconsin Statutes and the petition for annexation filed with the City Clerk of the City of Oconomowoc on the 30th day of August, 2006, the following described territory in the Town of Oconomowoc, Waukesha County, Wisconsin, is annexed to and made part of the City of Oconomowoc, Waukesha County, Wisconsin:

## (See legal description and map attached hereto)

SECTION 2. <u>EFFECT OF ANNEXATION</u>. From and after the date of this ordinance, the territory described in Section 1 shall be a part of the City of Oconomowoc, Waukesha County, Wisconsin, for any and all purposes provided by law, and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of Oconomowoc, Waukesha County, Wisconsin

SECTION 3. <u>WARD AND ALDERMANIC DISTRICT DESIGNATION</u>. The territory described in Section 1 of this ordinance is hereby made Ward 2, First Aldermanic District of the City of Oconomowoc, subject to the ordinances, rules and regulations of the city governing wards and aldermanic districts.

## SECTION 4. TEMPORARY ZONING CLASSIFICATION.

- (1) Upon recommendation of the Plan Commission, the territory annexed to the City of Oconomowoc by this ordinance is temporarily designated to be part of the SR-4 Suburban Residential District of the City of Oconomowoc for zoning purposes, as designated on the legal description and map attached hereto, and subject to all the provisions of Chapter 17 of the Municipal Code of the City of Oconomowoc relating to such district classification and to zoning in the City of Oconomowoc.
- (2) The Plan Commission is directed to prepare an amendment to the zoning ordinance setting forth a permanent classification and regulation for the zoning of the annexed area and to submit its recommendation to the Common Council.

SECTION 5. <u>SEVERABILITY</u>. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.

SECTION 6. <u>EFFECTIVE DATE</u>. This ordinance shall take effect upon passage and publication as required by law.




