AN ORDINANCE TO ANNEX LANDS LOCATED IN THE SOUTHWEST ¼ OF THE SOUTHEAST ¼ IN SECTION 32, TOWNSHIP 17 NORTH, RANGE 7 WEST FROM THE TOWN OF ONALASKA TO THE CITY OF ONALASKA

THE COMMON COUNCIL OF THE CITY OF ONALASKA DOES HEREBY ORDAIN AS FOLLOWS:
