
RE: VILLAGE OF PLAIN ANNEXATION OF TERRITORY, MBR# 13250

**ORDINANCE 158-08
OF THE VILLAGE OF PLAIN
SAUK COUNTY, WISCONSIN**

**ANNEXING CERTAIN TERRITORY FROM THE TOWN OF FRANKLIN,
SAUK COUNTY, TO THE VILLAGE OF PLAIN, WISCONSIN**

WHEREAS the owners of all the real property in the territory described below, located in the Town of Franklin, Sauk County, Wisconsin, filed a petition for direct annexation with the Village Clerk on April 10, 2008 and there are no electors residing within the territory within the definition of Wisconsin Statute § 66.0217(2); and

WHEREAS these lands are contiguous to the Village; and

WHEREAS the Division of Intergovernmental Relations and Municipal Boundary Review of the Department of Administration of the State of Wisconsin has reviewed the annexation and found it to be in the public interest; and

WHEREAS the annexation of the territory contained within this annexation is in the best interests of the Village:

NOW, THEREFORE, the Village Board of the Village of Plain do ordain as follows:

SECTION 1. Territory Annexed. In accordance with Sec. 66.0217 of the Wisconsin Statutes, the following described territory in the Town of Franklin, Sauk County, Wisconsin, is annexed to the Village of Plain, Wisconsin:

Located in part of Lot 12, of the Assessor's Plat of the Village of Plain, SE $\frac{1}{4}$ -SW $\frac{1}{4}$ and the NE $\frac{1}{4}$ -SW $\frac{1}{4}$, Section 5, T9N, R4E, Town of Franklin, Sauk County, Wisconsin, bounded by the following described line:

Commencing 140 feet North of a point where the north line of Cedar Street intersects with the west line of St. Luke's Avenue in the Village of Plain; thence West to the west line of said SE $\frac{1}{4}$ -SW $\frac{1}{4}$; thence North along the west line of said SE $\frac{1}{4}$ -SW $\frac{1}{4}$ and NE $\frac{1}{4}$ -SW $\frac{1}{4}$ to northwest corner of said NE $\frac{1}{4}$ -SW $\frac{1}{4}$; thence East along the north line of said NE $\frac{1}{4}$ -SW $\frac{1}{4}$ to the northeast corner of said NE $\frac{1}{4}$ -SW $\frac{1}{4}$; thence South along the east line of said NE $\frac{1}{4}$ -SW $\frac{1}{4}$ and SE $\frac{1}{4}$ -SW $\frac{1}{4}$ to a point being 685.48 feet north of the S $\frac{1}{4}$ corner of said Section 5; thence S89°20'50"W, 65.66 feet to the west line of S.T.H. 23; thence North along west line of S.T.H. 23 and east line of Lot 1, CSM No. 5629 to the thread of Honey Creek and northeast corner of said Lot 1, CSM No. 5629; thence Westerly along thread of Honey Creek and north line of said Lot 1 to northwest corner of said Lot 1; thence South along the west line of said Lot 1 to point of beginning.



SECTION 2. Effect of Annexation. From and after the date of this ordinance, the territory described in Section 1 shall be a part of the Village of Plain for any and all purposes provided by law, and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the Village of Plain.

SECTION 3. Severability. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.

SECTION 4. Effective Date. This ordinance shall take effect upon passage and publication as provided by law.

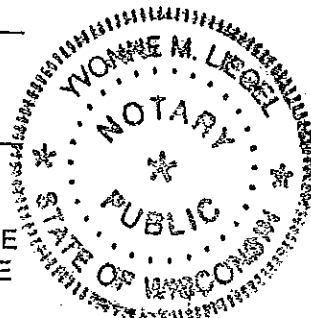

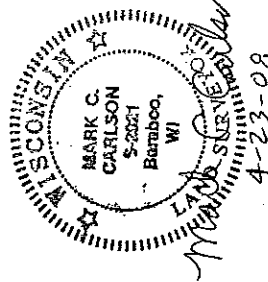
VILLAGE OF PLAIN ANNEXATION MAP

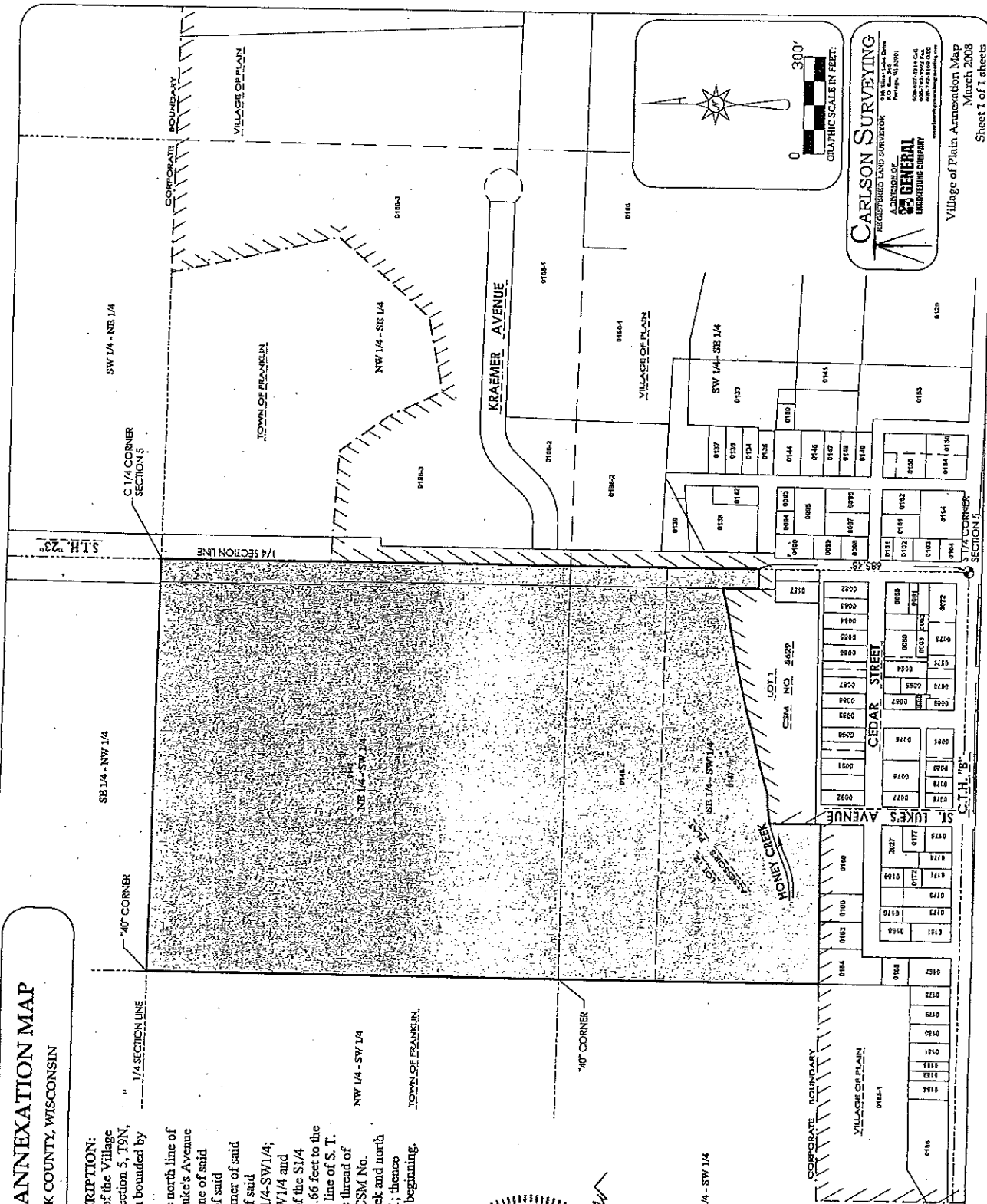
