ORDINANCE NO. 1205-0608

THE COMMON COUNCIL OF THE CITY OF STURGEON BAY, WISCONSIN DO ORDAIN
AS FOLLOWS:

SECTION 1: Territory Annexed. In accordance with Sec. 66.0217 of the Wisconsin Statutes and the petition for direct annexation filed with city clerk on the 20th day of January, 2008, signed by all of the owners of lands lying within the territory and all of the electors residing in such territory, the following described territory in the Town of Nasewaupée, Door County, Wisconsin, is annexed into the City of Sturgeon Bay, Wisconsin.

A tract of land located in the NE ¼ of the SE ¼, Section 12, Township 27 North, Range 25 East, described as follows: Commencing at the Southeast corner of said NE ¼ of the SE ¼ of said Section 12, (said point also being on the centerline of South Duluth Avenue); thence West a distance of 175 feet to the point of beginning; thence continue West a distance of 50 feet; thence North a distance of 180 feet; thence East a distance of 225 feet to the centerline of South Duluth Avenue; thence South along said centerline of South Duluth Avenue a distance of 120 feet; thence West a distance of 175 feet; thence South a distance of 60 feet to the point of real beginning.

The territory annexed contains 0.69 acre and is currently owned by Jeffrey & Laura Hoffman, parcel #0200112272541G.

SECTION 2: Effect of Annexation. From and after the date of this ordinance, the territory hereinafter described in Section 1 shall be part of the City of Sturgeon Bay, Door County, Wisconsin, for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules, and regulations governing the City of Sturgeon Bay.

SECTION 3: Temporary Zoning Classification. Upon recommendation of the Plan Commission of the City of Sturgeon Bay, the territory annexed to the City of Sturgeon Bay by this ordinance is temporarily zoned as Single-Family Residential (R-2) pursuant to Sec. 66.0217(8)(a) of the Wisconsin Statutes.

SECTION 4: Severability. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstance is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.

SECTION 5: This ordinance shall take effect on the day after its publication.

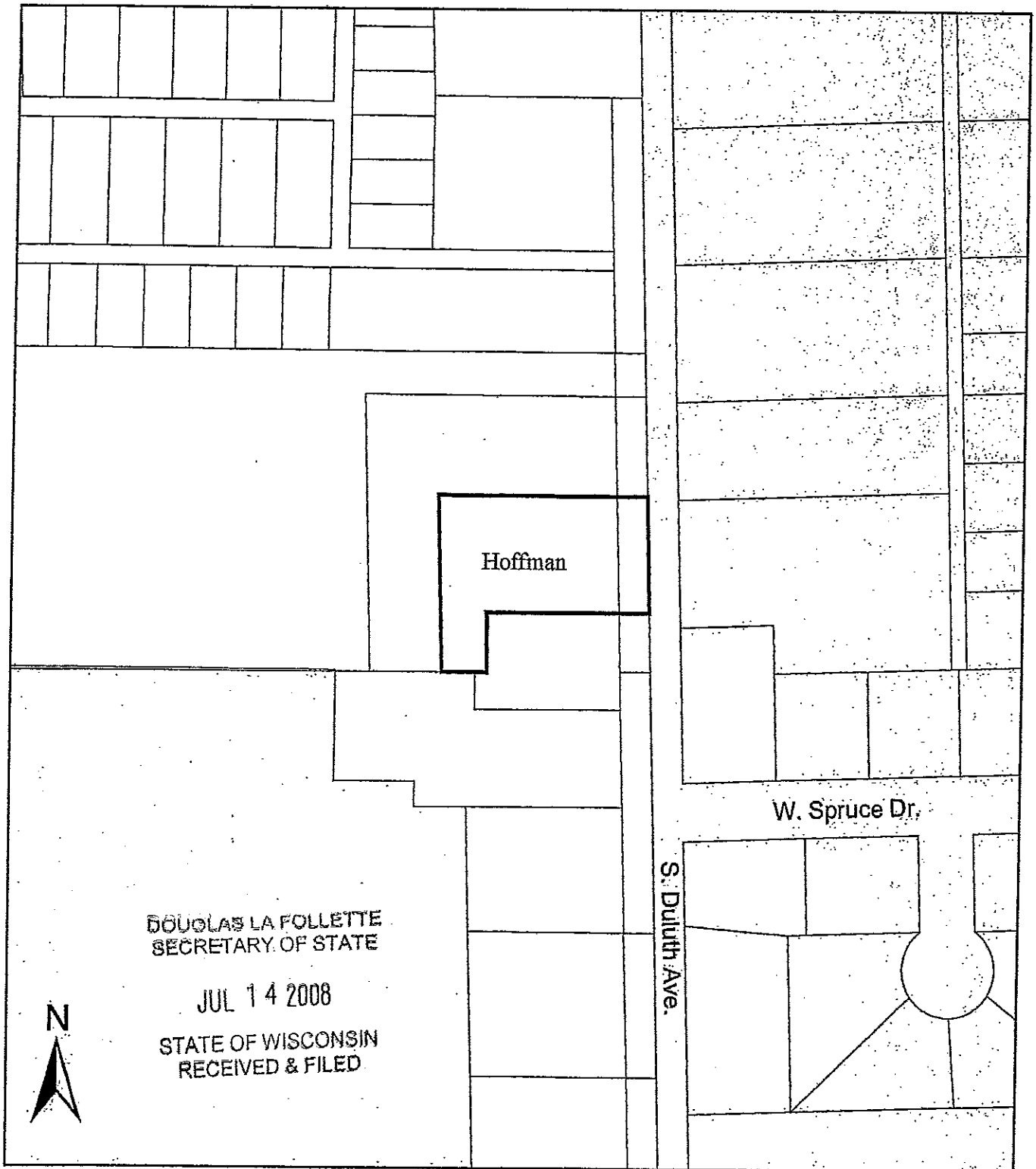

Annexation of Territory - Hoffman

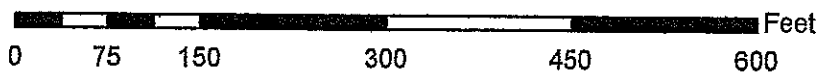


Annexation Area
