### **ORDINANCE #938**

AN ORDINANCE ANNEXING TERRITORY TO THE CITY OF MEDFORD

THE COMMON COUNCIL OF THE CITY OF MEDFORD, TAYLOR COUNTY, WISCONSIN, DO HEREBY ORDAIN AS FOLLOWS:

SECTION 1: <u>Territory Annexed.</u> In accordance with Wisconsin State Statute 66.0217 and the petition for direct annexation filed with the City Clerk on November 24, 2008, signed by all the electors and all of the owners of real property in the territory to be annexed, the following described territory in the Town of Little Black, Taylor County, Wisconsin, is annexed to the City of Medford, Wisconsin:

#### ANNEXATION LEGAL DESCRIPTION

Part Of Fractional NW 1/4 NW 1/4, That Part Laying East Of Hwy "13" Except South 21 Rods, Except Lot 1 CSM 5-S/277 (ex Hwy "O" R/w .23 acres), Section 1, Township 30 North, Range 1 East

- SECTION 2: <u>Effect of Annexation.</u> From and after the date of this ordinance, the territory described in Section 1 shall be part of the City of Medford for any and all purposes provided by law and persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of Medford.
- SECTION 3: <u>Zoning Classification</u>. Upon recommendation of the Plan Commission, the territory annexed to the City of Medford by this ordinance is temporarily designated to be a part of the C-1 Commercial District, for zoning purposes and subject to all provisions of the City of Medford Zoning Code.
- SECTION 4: <u>Property Tax Allocation</u>. Upon enactment of Ordinance # 938, the City of Medford hereby agrees to pay annually, pursuant to Wis. State sec 66.0217(14)(a) 1 to the Town of Little Black, for five years, an amount equal to the amount of property taxes that the Town levied on the annexed territory, as shown by the tax roll under Wis. Statutes Sec 70.65, in the year in which the annexation is final.
- SECTION 5: <u>Ward Designation.</u> The territory described in Section 1 of this ordinance is hereby made a part of Wards 4, Aldermanic District #2 of the City of Medford, subject to the ordinances, rules and regulations of the City governing wards.
- SECTION 6: <u>Severability.</u> If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstance is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.
- SECTION 7: <u>Effective Date.</u> This ordinance shall take effect upon passage and publication as provided by law.
