WHEREAS, David W. and Judith R. Frohling, trustees of the David W. and Judith R. Frohling Revocable Trust, owners, have filed with the Common Council a Petition for Direct Annexation of Real Estate by Unanimous Approval with the City of Watertown, Jefferson and Dodge Counties, Wisconsin; and

WHEREAS, a copy of said Petition has been reviewed by the Watertown Plan Commission and the State of Wisconsin Department of Administration, and has been given to the Town Clerk of the Town of Watertown in compliance with Section 66.0217 (2) of the Wisconsin Statutes: and

WHEREAS, the Watertown Plan Commission and the State of Wisconsin Department of Administration have indicated their support for the annexation.

NOW, THEREFORE, THE COMMON COUNCIL OF THE CITY OF WATERTOWN DO ORDAIN AS FOLLOWS:

SECTION 1. That the following described real estate be, and the same is, hereby annexed to the corporate city limits of the City of Watertown, from the Town of Watertown, Jefferson County, Wisconsin, to-wit:

A part of the Northwest 1/4 and the Southwest 1/4 of the Northwest 1/4 of Section 21, Town 8 North, Range 15 East, Town of Watertown, Jefferson County, Wisconsin, bounded and described as follows:

Commencing at the Northwest ¼ of said Section 21, said point being the Place of Beginning of the following description:

IT IS FURTHER ORDAINED AS FOLLOWS:

Permission is granted by the City for the entire annexed property to utilize a private well for water supply and a private septic system for sanitary waste disposal at this location, subject to compulsory and mandatory connection to public water and public sewer facilities to be provided by the City, pursuant to Section 10.12 of the Watertown General Ordinances, for sanitary sewer and water main connection in the future upon the occurrence of any one of the following events:

- 1. Any subsequent land divisions or subdivisions within the annexed property; or
- 2. Any subsequent addition of principal buildings or principal building expansions within the entire annexed property, except for the initial principal building erected by Archie Monument and Stone, Inc.; or
- 3. When water main and/or sanitary sewer main is extended by the City or private contractor to a point adjacent to any portion of the annexed property.
- 4. When the onsite private well and/or private septic system facilities no longer comply with state standards and are deemed to be in a failing condition.
- 5. Any provision of public water facilities and public sewer facilities will be installed at the property owner's expense either through special assessment or installation by private contractor.

IT IS FURTHER ORDAINED AS FOLLOWS:

That the Petitioners; David W. and Judith R. Frohling, shall be liable to the City of Watertown for the amount of the property taxes paid to the Town of Watertown, based upon the amount of property taxes that the Town levied on the annexed territory, as shown on the tax roll for the 2008 tax year, for the next five (5) years, in five (5) equal annual installments due and payable to the City of Watertown on or before December 31 of each of the next five (5) years commencing with the first such payment due and owing on or before December 31, 2008, pursuant to Section 66.0217 (14) (a) of the Wisconsin Statutes.

SECTION 2. All ordinances or parts of ordinances inconsistent with the provisions of this ordinance are hereby repealed.

SECTION 3. This ordinance shall take effect and be in force the day after its passage and publication.
