

#### **ORDINANCE RC-276**

# An ordinance annexing certain contiguous land located in the Town of Darien, Walworth County, Wisconsin. MBR 13362

WHEREAS, Walworth County Metropolitan Sewerage District has filed with the City Clerk of the City of Delavan a Petition for Direct Annexation by Unanimous Approval of lands situated in the Town of Darien, as the sole owner(s) of said land proposed for annexation, and said petition containing a description of the territory proposed to be annexed, sufficiently accurate to determine its location, and having attached thereto scale maps reasonably showing the boundaries of such territory and the relation of the territory to the municipalities involved; and

WHEREAS, the said Walworth County Metropolitan Sewerage District owns the real property described in said petition and in the Exhibit "A" attached hereto, all of said described land being referred to herein as the "territory proposed to be annexed"; and

WHEREAS, the parcel of land described in the City's attached Exhibit "A", and comprising territory proposed to be annexed, is contiguous to the City; and

WHEREAS, said petition states that there are no electors residing in said territory proposed to be annexed; and

WHEREAS, said Petition for Direct Annexation, together with legal description and attached scale maps showing the boundaries of such territory to be annexed and the relation of the territory to the City to which annexation is requested, were filed on May 12, 2009 with the City Clerk of the City of Delavan, and said petition together with legal description and attached scale map, were also mailed to the Town Clerk of the Town of Darien on May 12, 2009; and

WHEREAS, copy of said Petition for Direct Annexation, together with the legal description and attached scale maps were received by the Wisconsin Department of Administration, on May 19, 2009; and

WHEREAS, the Wisconsin Department of Administration has responded by letter dated June 8, 2009, and stated that it has reviewed the proposed annexation and found it to be in the public interest, which letter has been duly considered and reviewed by the Council; and

WHEREAS, the proposed annexation, including the proposed temporary zoning classification of Institutional (I) for the subject territory have been referred to the Plan Commission of this City and said Commission has on June 15, 2009 recommended annexing said territory and giving the same the requested temporary zoning classification of Institutional (I); and

WHEREAS, the Common Council makes the following findings with respect to the territory proposed to be annexed, to-wit:

- 1. That the annexation of said property to the City of Delavan is in the public interest.
- 2. That said contiguous lands of the territory proposed to be annexed and the future use thereof will be important to the future quality of life of this City.

NOW, THEREFORE, The Common Council of the City of Delavan, Walworth County, Wisconsin, does ordain as follows:

- 1. The described lands located in the Town of Darien, Walworth County, Wisconsin, comprising the territory to be annexed, as described in attached Exhibit "A", be and the same is hereby annexed to the City of Delavan;
- 2. That the land described in said Exhibit "A" is hereby annexed to and made the thirteenth ward in the First Aldermanic District of the City of Delavan;
- 3. That said land is hereby given a temporary zoning classification of Institutional (I);
- 4. The annexation hereby effected is and shall be effective upon the final enactment of this annexation ordinance;
- 5. The Clerk shall immediately after the final enactment hereof, file with the Secretary of State a certified copy of this ordinance, certificate and plat and one copy thereof to each company that provided any utility service in the area annexed plus one such copy with the Register of Deeds and one copy with the Secretary of the Delavan-Darien School District signed by said Clerk, describing the territory which is hereby annexed and the associated population of zero (0).

## WalCoMet Annexation - Legal Description
