AMENDING SECTION C.02 APPOINTED OFFICIALS AND  
C.03 EMPLOYED OFFICIALS OF THE VILLAGE CODE

An ordinance to amend Section C.02 and C.03 of the Municipal Code of the Village of Bloomfield, Walworth County, Wisconsin.

The Village Board of the Village of Bloomfield, Walworth County, Wisconsin, does hereby ordain as follows:

Section One: Section C.02 and C.03 of the Municipal Code of the Village of Bloomfield, Walworth County, Wisconsin is hereby amended, as follows:

**C.02 APPOINTED OFFICIALS.**

1. *Appointed Officials.* The appointed officials of the Village shall consist of the following.

<b>Official</b>	<b>How Selected</b>	<b>By Contract Employment</b>
Village Attorney (Legal Counsel)	Village President, subject to approval of Village Board	Part-time consultant on as-needed basis
Village Assessor	Village President, subject to approval of Village Board	By Contract
Village Building Inspector	Village President, subject to approval of Village Board	By Contract
Village Planner	Village President, subject to approval of Village Board	Part-time consultant on as-needed basis
Village Engineer	Village President, subject to approval of Village Board	Part-time consultant on as-needed basis
Village Auditor	Village President, subject to approval of Village Board	Part-time consultant on as-needed basis

2. Procedure: Elected Officials must get direction from the Village President prior to contacting Appointed Officials that charge fees per hour, unless approved by proper motion of the Village Board.
3. Abuse of this section may be considered grounds for removal from office.

**C.03 EMPLOYED OFFICIALS.**

1. *Employed Officials.* The following employed officials shall serve subject to satisfactory performance and in accordance with the standard employment practice guidelines. Employed officials shall serve for a probationary period to be set at the time of selection.



2. **DISCONTINUANCE OF OFFICE.** The Village Board does hereby discontinue the office of the Village Marshal and Village Constable.
3. The Village pursuant to §§ 61.195 and 66.0101 hereby elects not to be governed by those portions of §§61.195 and 61.197 which are in conflict with this section.

Section Two: Pursuant to Wis. Stat. § 66.0101(5 (2015-16), this Ordinance shall be effective 60 days after its passage and publication.
