ORDINANCE NO 2026-O-C11

AMENDING SECTION C.03 OF THE VILLAGE CODE
REGARDING EMPLOYED OFFICIALS

THE VILLAGE BOARD OF THE VILLAGE OF BLOOMFIELD, WALWORTH COUNTY, WISCONSIN, does hereby ordain the following changes to the Village Code:

Section I: Pursuant to Wis. Stat. §§ 66.0101 and 61.195, and other applicable laws, following the effective date of this Charter Ordinance, the Offices of Village Clerk and Village Treasurer shall be consolidated into one position, the Office of Village Clerk-Treasurer.

Section II: The Village Clerk-Treasurer shall perform all duties required by Wisconsin law, Village ordinances, and those other duties as the Village Administrator directs to be executed by the Village Clerk-Treasurer from time to time.

Section III: All ordinances or parts of ordinances in direct conflict herewith are hereby repealed. Notwithstanding this Section, any use of the office of "Village Clerk" or "Village Treasurer" in the Village of Bloomfield Code is hereby amended by replacing that office or those offices with the consolidated office of "Village Clerk-Treasurer".

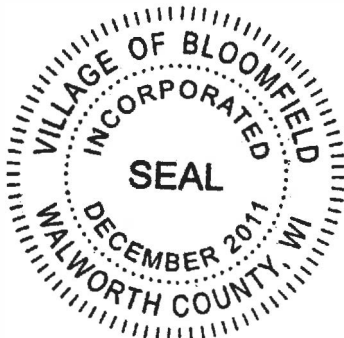
Section IV: This is a charter ordinance and shall take effect sixty (60) days after its passage and publication as provided for by Wis. Stat. § 66.0101, unless within such sixty (60) days a referendum petition shall be filed as provided by Wis. Stat. § 66.0101(5), in which event this Charter Ordinance shall not take effect until submitted to a referendum and approved by a majority of the electors voting thereon.

Section V: The Village Clerk shall cause this Charter Ordinance to be published as a Class 1 notice, under Chapter 985 of the Wisconsin Statutes, and shall file a certified copy of this Charter Ordinance with the Wisconsin Secretary of State.

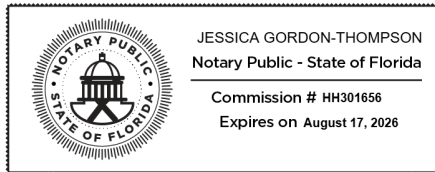
