The Village of Rothschild has recently changed three of its Charter Ordinances, specifically numbers 1, 2 and 7. I have included a signed copy of each with an accompanying certification statement.

Charter Ordinance No. 1 was amended to reflect that the Village now has only a police commission instead of a police and fire commission. This is due to the creation of a joint municipal fire department that has been created for service to the Village and it has a different governance structure.

Charter Ordinance No. 2 was repealed. This had created the Village office of Justice of the Peace, which office no longer exists in Wisconsin. The Village noticed that this had not yet been repealed while creating a joint municipal court recently.

Charter Ordinance No. 7 was amended to create separately appointed offices of Clerk and Treasurer, whereas previously the Village has had an appointed joint office of Clerk-Treasurer.

## AMENDMENT TO CHARTER ORDINANCE NO. 7

The Village Board of the Village of Rothschild, Marathon County, Wisconsin, do ordain as follows:

<u>Section 1:</u> CHARTER ORDINANCE NO. 7 of the Village of Rothschild is hereby amended with new language <u>underlined</u> and deleted language <u>stricken</u> to provide as follows:

## Charter Ordinance No. 7

NOW THEREFORE, The Village Board of the Village of Rothschild do ordain as follows:

SECTION 1. Clerk Treasurer, Combination of Offices – the offices of clerk and treasurer of the Village of Rothschild, Marathon County, Wisconsin shall be combined effective May 1, 1975. The offices of Clerk and Treasurer of the Village of Rothschild, Marathon County, Wisconsin shall be separate and not consolidated as of the effective date of this Charter Ordinance.

SECTION 2. Appointment of Clerk Treasurer Clerk and Treasurer – the combined clerktreasurer offices of Clerk and Treasurer of the Village of Rothschild shall be appointed by the president subject to confirmation by the Village Board, the first appointments to be effective May 1, 1975 upon being made after adoption of this Charter Ordinance.

SECTION 3. Terms – the combined clerk-treasurerClerk and Treasurer shall each serve at the pleasure of the Village Board and shall be removed by a majority vote of all the members of the Village Board.

SECTION 4. All ordinances, parts of ordinances and charter ordinances in conflict herewith are hereby repealed.

SECTION 5. This ordinance shall be in full force and effect sixty (60) days after its passage and publication unless within such sixty (60) days, a Petition for referendum is filed pursuant to and in compliance with Section 66.01 of the Wisconsin Statutes, and in such case only upon its approval as a referendum.

<u>Section 2:</u> If any provision of this Charter Ordinance is invalid or unconstitutional or if the application of this Charter Ordinance to any person or circumstances is found invalid or unconstitutional by a Court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the provisions or application of this Charter Ordinance which can be given effect without the invalid or unconstitutional provisions or applications.

<u>Section 3:</u> All Charter Ordinances, parts of Charter Ordinances, Ordinances and parts of Ordinances in conflict herewith are hereby repealed.

This Charter Ordinance shall be in full force and effect from and after its Section 4: date of passage by at least two-thirds (2/3) of the Village Board, notice to the public as required by law and the passage of sixty (60) days; or in separate case as pursuant to Wis. Stat. § 66.0101(5).
