CHARTER ORDINANCE NUMBERS 1, 2, 3, 4, 5, AND 6 Wisconsin Dept. of Admin.

An Ordinance to Repeal and Recreate the Village Charter Ordinances Regarding the Office of Village Treasurer, Assessor, and Clerk, the Inclusion of Village Personnel in State Retirement Fund, the Office Constable, and the Election and Term of the Municipal Judge

The Village Board of the Village of Bayside, Milwaukee and Ozaukee Counties, Wisconsin does ordain as follows:

Section One: Charter Ordinance Numbers 1, 2, 3, 4, 5, 6, 7, 8, 9, 10 and 11 are hereby repealed.

Section Two: Charter Ordinance Number 1 is hereby recreated to read as follows:

CHARTER ORDINANCE NO. 1 – VILLAGE TREASURER

(a) – Selection.

Pursuant to Wis. Stats. §§ 61.195, 61.197 and 66.0101, the Village hereby elects not to be governed by the portions of Wis. Stats. §§ 61.19, 61.23, 61.25 and 61.26, which relate to the election and tenure of the Treasurer, and which are in conflict with this section.

(b) – Appointment.

Instead of being elected as provided in Wis. Stats. § 61.19, the Village Treasurer shall be appointed by a six-sevenths vote of the members elected to the Village Board.

(c) – Qualifications.

The Village Treasurer shall be appointed purely on merit. In appointing the Treasurer, the Village Board shall give due regard to training, experience, efficiency and general qualification and fitness for performing the duties of the office; and no person shall be eligible for appointment who is not by training, experience, ability and efficiency well qualified and generally fitted to perform the duties of the office. No weight or consideration shall be given to nationality, political or religious affiliations, or to any other considerations except merit and direct qualifications for the office.

(d) - Term.

The Village Treasurer shall hold office for an indefinite term, subject to removal as provided by law.

Section Three: Charter Ordinance Number 2 is hereby recreated to read as follows:

CHARTER ORDINANCE NO. 2 – VILLAGE ASSESSOR

(a) – Selection.

Pursuant to Wis. Stats. §§ 61.195, 61.197 and 66.01, the Village hereby elects not to be governed by the portions of Wis. Stats. §§ 61.19, 61.23 and 61.25, which relate to the election and tenure of the Assessor, and which are in conflict with this section.

(b) – Appointment.

Instead of being elected as provided by Wis. Stats. § 61.19, the Village Assessor shall be appointed by a six-sevenths vote of the members elected to the Village Board.

(c) – Qualifications.

The Village Assessor shall be appointed purely on merit. In appointing the Assessor, the Village Board shall give due regard to training, experience, efficiency and general qualification and fitness for performing the duties of the office; and no person shall be eligible for appointment who is not by training, experience, ability and efficiency well qualified and generally fitted to perform the duties of the office. No weight or consideration shall be given to nationality, political or religious affiliations or to any other considerations except merit and direct qualifications for the office.

(d) – Term.

The Village Assessor shall hold office for an indefinite term, subject to removal as provided by law.

Section Four: Charter Ordinance Number 3 is hereby recreated to read as follows:

CHARTER ORDINANCE NO. 3 – VILLAGE CLERK

(a) – Selection.

Pursuant to Wis. Stats. §§ 61.195 and 66.0101, the Village hereby elects not to be governed by the portions of Wis. Stats. §§ 61.19, 61.23 and 61.25, which relate to the election tenure of the Clerk, and which are in conflict with this section.

(b) – Appointment.

Instead of being elected as provided in Wis. Stats. § 61.19, the Village Clerk shall be appointed by a six-sevenths vote of the members elected to the Village Board.

(c) – Qualifications.

The Village Clerk shall be appointed purely on merit. In appointing the Clerk, the Village Board shall give due regard to training, experience, efficiency and general qualification and fitness for performing the duties of the office; and no person shall be eligible for appointment who is not by training, experience, ability and efficiency well qualified and generally fitted to perform the duties of the office. No weight or consideration shall be given to nationality, political or religious affiliations, or to any other considerations except merit and direct qualifications for the office.

(d) - Term.

The Village Clerk shall hold office for an indefinite term, subject to removal as provided by law.

Section Five: Charter Ordinance Number 4 is hereby recreated to read as follows:

CHARTER ORDINANCE NO. 4 – VILLAGE PERSONNEL INCLUDED IN STATE RETIREMENT FUND

(a) – Pursuant to Wis. Stats. § 40.21, the Village elects to include eligible Village personnel under the provisions of the state retirement fund in accordance with the terms thereof.

(b) – Election is hereby made to provide prior service credits at rate equal to two times the rate of municipality credits for current service, to be applicable to employees, as defined by the Wisconsin Statutes, who are employed by the Village on the effective date.

(c) – The effective date of participation shall be January 1, 1957.

Section Six: Charter Ordinance Number 5 is hereby recreated to read as follows:

CHARTER ORDINANCE NO. 5 – OFFICE OF CONSTABLE ABOLISHED

(a) The Village of Bayside hereby elects not to be governed by the provisions of Sections 66.19, 61.28, 61.29 or any other provision of the Wisconsin Statutes, insofar as the same requires or authorizes the election or appointment of a constable in villages, and hereby elects to and does hereby abolish and discontinue the Office of Constable in the Village of Bayside.

Section Seven: Charter Ordinance Number 6 is hereby recreated to read as follows:

CHARTER ORDINANCE NO. 6 – ELECTION, TERM OF JUDGE

(a) The Municipal Judge shall be elected at the spring election for a term of three years commencing on May 1 succeeding election.

<u>Section Eight</u>: Severability: In the event that any provision of this Ordinance is for any reason held to be invalid, unconstitutional, or unenforceable by any court of competent jurisdiction, such portions of this Ordinance shall be deemed separate, distinct and independent provisions of the Ordinance and all remaining portions of this Ordinance shall remain in full force and effect.

<u>Section Nine</u>: Any ordinances or resolutions or portions thereof of which conflict further with this ordinance are hereby and to such extent repealed.

- (f) Character of surrounding area relative the character of defendant, treatment, or the prior offense or offenses.
- (g) Recommendation of any treating practitioner.
- (h) Proposals for safety assurances of person on the Registry.
- (i) Conditions to be placed on any exception from the requirements of the Ordinance.

<u>Section Two</u>: Severability: In the event that any provision of this Ordinance is for any reason held to be invalid, unconstitutional, or unenforceable by any court of competent jurisdiction, such portions of this Ordinance shall be deemed separate, distinct and independent provisions of the Ordinance and all remaining portions of this Ordinance shall remain in full force and effect.

Section Three. All ordinances or parts of ordinances conflicting with the provisions of this ordinance are hereby to such extent repealed.

Section Four. This ordinance shall take effect and be in force after its passage and posting pursuant to law.
