**VILLAGE CHARTER ORDINANCE NO. 101-A**

**A CHARTER ORDINANCE REPEALING AND RECREATING  
CHARTER ORDINANCE NO. 101 CREATING THE SEPARATE OFFICES OF  
CLERK AND TREASURER AND AMENDING CHAPTER 1, GENERAL  
GOVERNMENT, SECTION 1.02(8), APPOINTED OFFICIALS OF THE  
MUNICIPAL CODE OF THE VILLAGE OF DENMARK**

**THE VILLAGE BOARD OF THE VILLAGE OF DENMARK, BROWN COUNTY,  
WISCONSIN, DOES ORDAIN AS FOLLOWS:**

**SECTION 1.** Pursuant to Sections 61.195, 61.197 and 66.0101, Wis. Stats., the Village of Denmark elects not to be governed by those portions of Sections 61.19, 61.23 and 61.25(2), Wis. Stats., which relate to the selection and tenure of the Village Clerk and the Village Treasurer, and which are in conflict with this ordinance.

**SECTION 2.** There is hereby created the separate offices of Village Clerk and Village Treasurer, who shall be appointed by the Village President, subject to confirmation by a majority vote of the members of the Village Board. The President shall not have a vote on such confirmation.

**SECTION. 3.** The Village Clerk and Village Treasurer, subject to approval by a majority of all the members of the Village Board, may, in writing, filed in his/her office, appoint a deputy who shall act under his/her direction and who, during the temporary absence or disability of the Clerk or Treasurer. The deputies shall receive such compensation as the Village Board shall determine. The acts of such deputies shall be covered by official bond as the Village Board shall direct.

**SECTION 4.** The Village Clerk and the Village Treasurer shall hold office for an indefinite term, subject to removal by the Village Board at its pleasure.

**SECTION 5.** The Village Clerk and Village Treasurer shall perform such other duties as shall be required from time to time by the Village Board. The compensation to be paid the Village Clerk and Village Treasurer shall be fixed annually by the Village Board and paid at the established payroll periods of the Village.

**SECTION 6.** Section 1.02 APPOINTED OFFICIALS. THE APPOINTED OFFICIALS OF THE Village shall be as follows:

**SECTION 7.** This is a Charter Ordinance and shall take effect 60 days after its passage and publication, unless, within such 60 days, a referendum petition shall be filed as provided by Section 66.0101, Wis. Stats., in which event, this Ordinance shall not take effect until submitted to a referendum and approved by a majority of the electors voting thereon.
