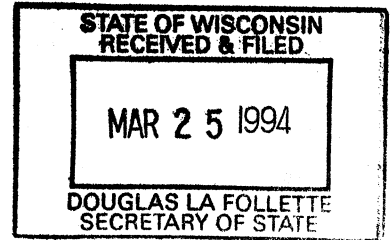

ORDINANCE 90-10

AN ORDINANCE TO ANNEX CERTAIN LANDS LOCATED IN THE TOWN OF VIENNA TO THE VILLAGE OF DEFOREST, DANE COUNTY, WISCONSIN.

WHEREAS, a petition for direct unanimous annexation pursuant to the provisions of Section 66.021 (12), Wisconsin Statutes, was filed with the Village Clerk of the Village of DeForest on October 4, 1990, and

WHEREAS, said petition complies with the requirements of Section 66.021 (44), Wisconsin Statutes, with respect to the information to be contained therein, and

WHEREAS, the DeForest/Vienna Joint Development Committee so unanimously voted to recommend the annexation, and

WHEREAS, governmental services can readily be provided to the property sought to be annexed in a cost effective manner, and

WHEREAS, the Department of Development has completed its review pursuant to Section 66.021 (11), Wisconsin Statutes, and has determined that the proposed annexation is not against the public interest.

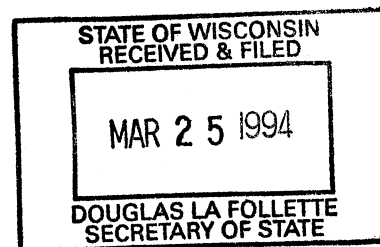
NOW, THEREFORE BE IT ORDAINED, that the Village Board of the Village of DeForest does ordain the following:

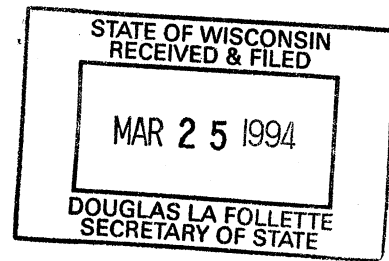
1. The property hereinafter described as annexed to and made a part of the Village of DeForest, Dane County, Wisconsin:

Land located in the NE 1/4 of the NE 1/4 of Section 24, T9N, R9E, Town of Vienna, Dane County, Wisconsin.
Commencing at the NE corner of Section 24, T9N, R9E, Town of Vienna Dane County, Wisconsin, which is also the point of beginning:


Thence south along the east line of said Section 24 to the north line of the SE 1/4 of the NE 1/4 of Section 24; thence west along said line to the centerline of River Road; thence northwest along the centerline of River Road approximately 600' to the intersection of the centerline of Hilltop Road; thence northeast along the centerline of Hilltop Road to the east line of "Hilltop" plat; thence continue northeast along the NW line of property owned by V. Acker to the northeast corner of Section 24 and the point of beginning.


2. Further, Exhibit A attached hereto and incorporated herein is a map reasonably showing the boundaries of such territory and the relation of the territory to the Municipalities involved.
3. This Ordinance shall become effective upon passage and publication as provided by law.

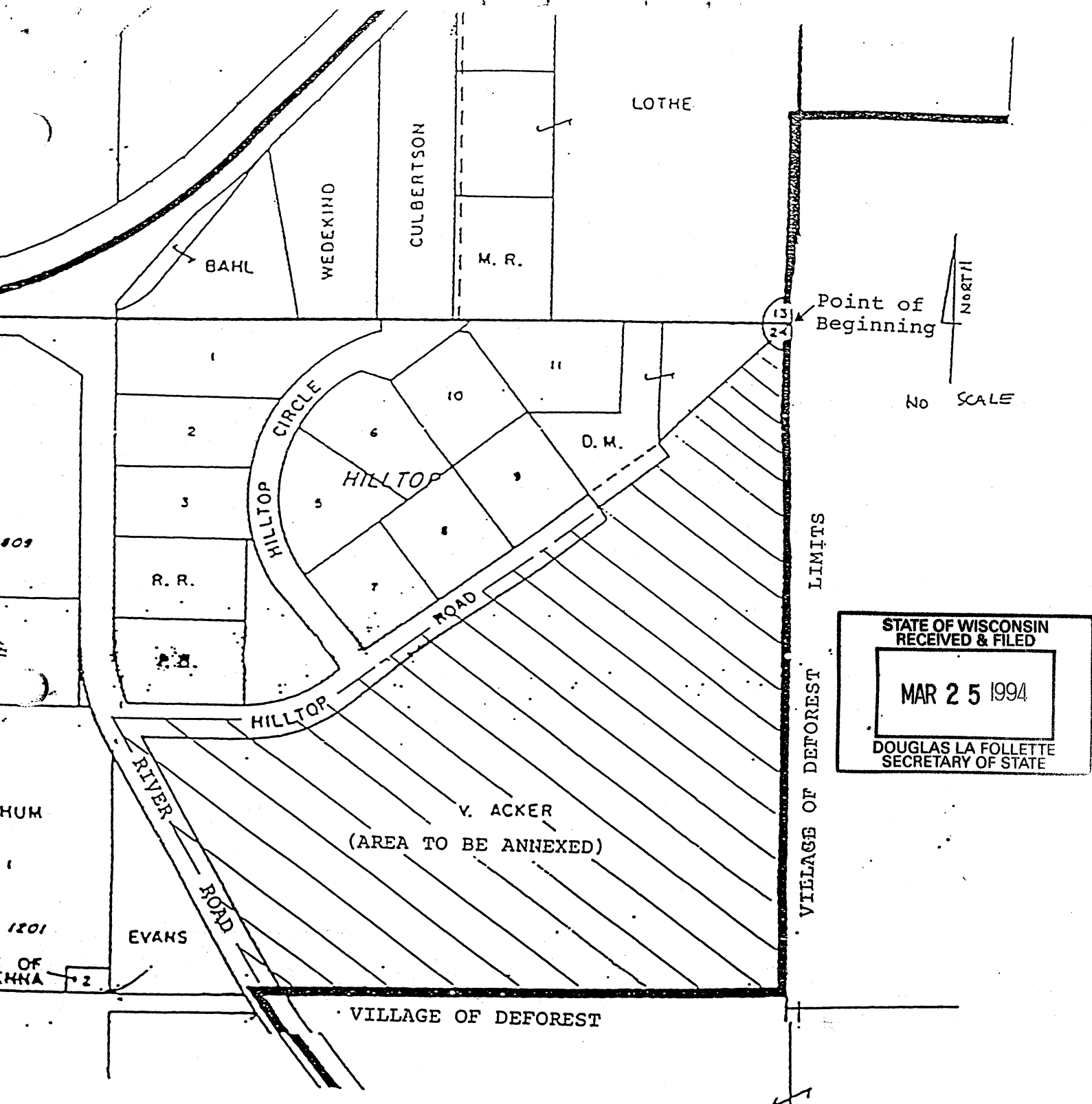
