

WHEREAS, pursuant to Wis. Stats. § 66.0301(6), the City of Madison and the City of Middleton entered into a Boundary Adjustment Agreement relating to the following described lands:

Part of the Southwest 1/4 of the Northwest 1/4 of Section 15, Township 7 North, Range 8 East, City of Madison, Dane County, Wisconsin, more fully described as follows:

The East 33 feet of the South 330 feet of the said Southwest 1/4 of the Northwest 1/4 of Section 15

WHEREAS, the Property consists of one-half of the improved public right of way of North Pleasant View Road, and the area thereof is depicted in Exhibit 1 attached hereto; and

WHEREAS, there are no resident electors within the Property; and

WHEREAS, the current population of the annexed Property is zero; and

WHEREAS, Ordinance No. O1377 adopting the said Boundary Change was previously adopted by the Middleton Common Council on January 20, 2015, and the Dane County Property Lister has requested revision of the Boundary Ordinance for the sole purpose of changing the designated State Senate, State Assembly, Dane County and City of Middleton District or Ward Designations, and in all other respects this Ordinance is identical to Ordinance No. O1377 adopted on January 20, 2015;

WHEREAS, the attachment of this Property to the City of Middleton is consistent with the Boundary Adjustment Agreement and is in the public interest;

NOW, THEREFORE, the Common Council of the City of Middleton, Wisconsin, does hereby ordain as follows:

- 1. In accordance with Wis. Stats. § 66.0301(6) and the Boundary Adjustment Agreement between the City of Madison and the City of Middleton, the Property is hereby detached from the City of Madison and attached to the City of Middleton, and is hereby located in the Middleton-Cross Plains Area School District, as well as Senate District 26, Assembly District 78, County Supervisory District 9, and City of Middleton Ward 21.
- 2. This Ordinance shall take effect following passage and publication. In addition, the City Clerk shall comply with the filing requirements for newly annexed territory specified in Wis. Stats. § 66.0217(9)(a).






