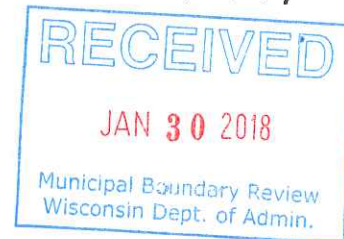

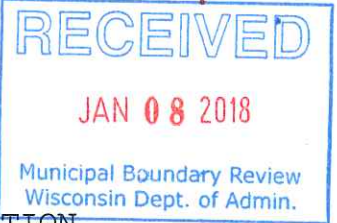

AN ORDINANCE annexing territory owned by the City to the City of
Sheboygan, Wisconsin.

THE COMMON COUNCIL OF THE CITY OF SHEBOYGAN DO ORDAIN AS FOLLOWS:

Section 1. **Territory Annexed.** In accordance with sec. 66.0223 of
the Wisconsin Statutes, the following described territory in the Town of
Wilson, Sheboygan County, Wisconsin, owned by the City of Sheboygan and
lying contiguous to the City, is hereby annexed to the City of Sheboygan,
Wisconsin:

The South 1/2 of the South 1/2 of the Southwest 1/4 and part of the West
1/2 of the Southwest 1/4 of the Southeast 1/4 in Section 10, Town 14
North, Range 23 East, Town of Wilson, Sheboygan County, Wisconsin bounded
and described as follows: Beginning at the Southwest corner of said
Southwest 1/4 Section, thence North 00°10'44" East along the West line of
said Southwest 1/4 Section 662.27 feet to a point on the North line of the
South 1/2 of the South 1/2 of said Southwest 1/4 Section; thence South
88°32'53" East along said North line 2596.11 feet to a point on the West
line of said Southeast 1/4 Section; thence South 88°31'19" East along the
City of Sheboygan Municipal Boundary 647.95 feet to a point on the East
line of the West 1/2 of the Southwest 1/4 of said Southeast 1/4 Section;
thence South 00°33'53" West along said East line 663.27 feet to a point on
the South line of said Southeast 1/4 Section; thence North 88°25'50" West
along said South line 648.61 feet to the Southeast corner of said
Southwest 1/4 Section; thence North 88°32'48" West along the South line of
said Southwest 1/4 Section 2591.01 feet to the point of beginning.
Containing 49.285 acres more or less.

Section 2. **Effect of Annexation.** This ordinance shall take effect
upon passage and publication, and upon the filing of seven (7) certified
copies of this ordinance in the office of the secretary of state of the
State of Wisconsin, together with seven (7) copies of a plat showing the
boundaries of the territory attached to the City. From and after the
effective date of this ordinance, the territory described in Section 1
shall be a part of the City of Sheboygan for any and all purposes provided
by law and all persons coming or residing within such territory shall be
subject to all ordinances, rules and regulations governing the City of
Sheboygan.

Section 3. **Ward Designation.** The territory described in Section 1
of this ordinance is hereby made a part of the ~~26th~~ Ward, 8th Aldermanic
District, 10th Supervisory District, 26th Assembly District and the 9th

23rd Ward

Senatorial District, subject to the ordinances, statutes, rules and regulations governing wards and districts.

Section 4. **Severability.** If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.

Section 5. **Zoning.** Upon recommendation of the Plan Commission, the territory annexed to the City by this ordinance is temporarily zoned as Suburban Residential 5 (SR-5), a designation that is consistent with the City of Sheboygan Comprehensive Plan for that area.

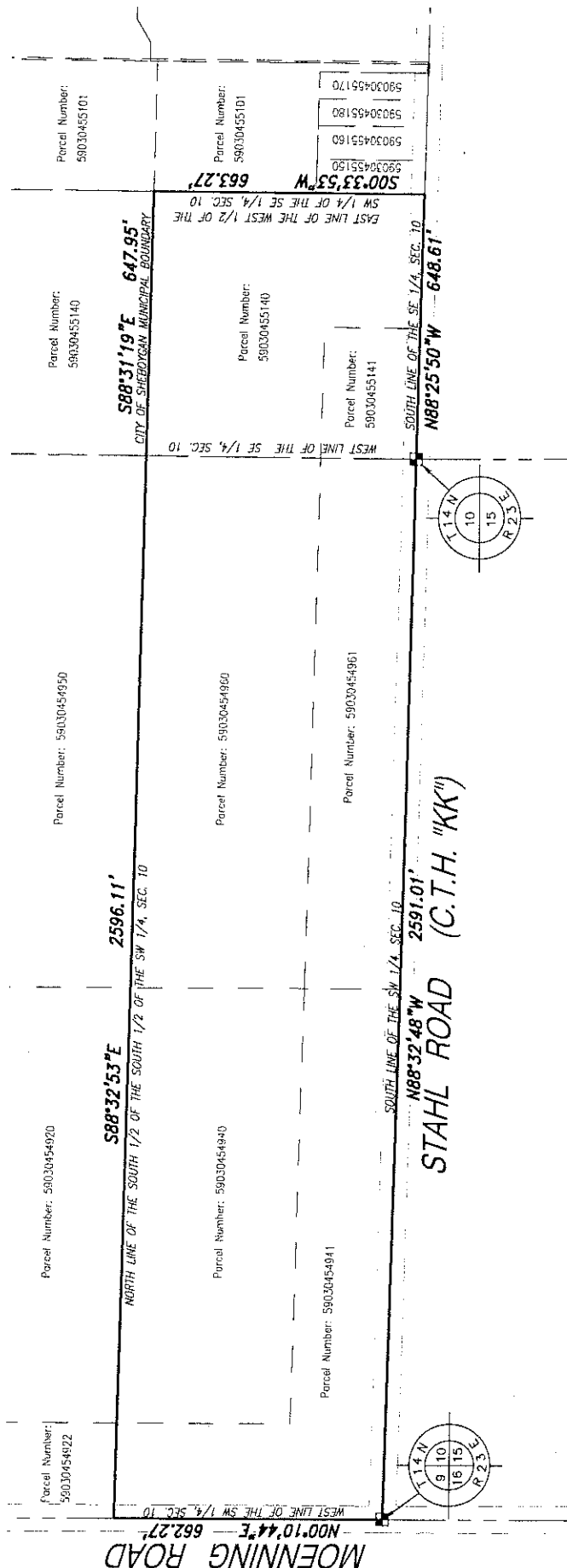
