AN ORDINANCE annexing territory from the Town of Wilson to the City of Sheboygan situated in the vicinity east of Racetrack Road and north of Stahl Road (Parcels 59030454501, 59030454502 and 59030454503).

THE COMMON COUNCIL OF THE CITY OF SHEBOYGAN DO ORDAIN AS FOLLOWS:

Section 1. In accordance with \$66.0217 of the Wisconsin Statutes and a petition for direct annexation filed with the City Clerk on the 16^{th} day of November, 2017, signed by the owners of the real property in the area in which no electors reside, the following described territory in the Town of Wilson, Sheboygan County, Wisconsin, is hereby annexed to the City of Sheboygan:

Section 2. From and after the effective date of this ordinance, the territory described in Section 1 shall be a part of the City of Sheboygan for any and all purposes provided by law, and all persons coming or residing in such territory shall be subject to all ordinances, rules and regulations governing the City of Sheboygan.

Appendix A, Chapter 15, of the Sheboygan Zoning Ordinance Section 3. establishing zoning districts and prescribing zoning standards regulations is hereby amended by changing the Official Zoning Map thereof and establishing the Use District Classification of said lands as SC Suburban Commercial.

Section 4. The territory described in Section 1 of this ordinance is hereby made a part of the 36th Ward, 10th Aldermanic District, of the City of 23rd Ward Sheboygan.

All ordinances or parts thereof in conflict with the Section 5. provisions of this ordinance are hereby repealed to the extent of such conflict, and this ordinance shall be in effect from and after its enactment.
