Attaching to the City of Kenosha, Wisconsin, territory in the Town of Somers, Kenosha County, Wisconsin, under Section 66.0307, Wisconsin Statutes, Second Amendment to the City of Kenosha/Town of Somers Cooperative Plan:

The Common Council of the City of Kenosha, Wisconsin, does ordain as follows:

Section One: Territory Attached. In accordance with City of Kenosha/Town of Somers Cooperative Plan under Section 66.0307 of the Wisconsin Statutes, approved by the Wisconsin Department of Administration, Intergovernmental Relations, Municipal Boundary Review, on August 8, 2005, the First Amendment to the City of Kenosha/Town of Somers Cooperative Plan under s. 66.0307 of the Wisconsin Statutes, approved by the Wisconsin Department of Administration, Intergovernmental Relations, Municipal Boundary Review, on September 15, 2015, and the Second Amendment to the City of Kenosha/ Town of Somers Cooperative Plan under s. 66.0307 of the Wisconsin Statutes with the last date of execution being October 3, 2017, the territory in the Town of Somers, Kenosha County, Wisconsin, with an associated population of none (0), legally described and shown on attached Exhibit "A", is hereby attached to the City of Kenosha, Wisconsin, as hereinafter provided.

Section Two: Effect of Attachment. From and after the effective date of this Ordinance, the territory described in Section One shall be a part of the City of Kenosha for any and all purposes provided by law, and all persons coming or residing within such territory shall be subject to all Ordinances, rules and

regulations governing the City of Kenosha.

Section Three: Severability. If any provision of this Ordinance is invalid or unconstitutional, or if the application of this Ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this Ordinance which can be given effect without the invalid or unconstitutional provision or application.

Section Four: Effective Date. This Ordinance shall become effective upon passage and publication.


DISTRICT MAP

CITY OF KENOSHA

Part of the Northwest Quarter of Section 4 and the Northeast Quarter of Section 5, both in Town 1 North, Range 22 East of the Fourth Principal Meridian, lying and being in the Town of Somers, Kenosha County, Wisconsin and being more particularly described as follows:

Commencing at the northwest comer of the Northwest Quarter of the aforesaid Section 4; thence S03°07'55"E along the west line of said Quarter Section, 33.04 feet and to the point of beginning; thence N89°33'27"E parallel to the north line of said Quarter Section, 56.45 feet; thence S43° 12'46"W 32.33 feet; thence S03°07'55"W parallel to the west line of the aforesaid Northwest Quarter Section, 1911.49 feet; thence S86°52'05"W 33.00 feet and to the west line of the aforesaid Northwest Quarter of Section 4, which line is also on the east line of the aforesaid Northeast Quarter of Section 5; thence S89°40'55'W 33.04 feet; thence N03°07'55"W parallel to the east line of aforesaid Northeast Quarter Section, 1909.87 feet thence N46°43'15"W 38.49 feet; thence N89°40'11"E parallel to the north line of the aforesaid Northeast Quarter Section, 59.61 feet and to the point of beginning.


Piat Showing
