ORDINANCE NO. 3657

AN ORDINANCE ANNEXING PROPERTY
TO THE CITY OF FOND DU LAC AND
CHANGE LIMITS TO INCLUDE PROPERTY WEST OF
ROLLING MEADOWS DRIVE BETWEEN STEENBURG
AVENUE AND MASCOUTIN VALLEY RECREATION TRAIL

The City Council of the City of Fond du Lac, Wisconsin, do ordain as follows:

Section 1. Property Annexed. In accordance with Section 66.0223, Wis. Stats., the following described territory, is hereby annexed to the City of Fond du Lac:

Part of the Northwest 1/4 and Northeast 1/4 of the Southeast 1/4, Section 5, Township 15 North, Range 17 East, Town of Fond du Lac, Fond du Lac County, Wisconsin being more particularly described as follows:

Commencing at the Southwest corner of the Southeast 1/4, said Section 5; thence North 02°-54'-52" West along the West line of said Southeast 1/4, a distance of 1,330.73 feet to Northerly line of the Former Chicago & Northwestern Railroad right-of-way (Mascoutin Valley Recreation Trail), said point being the point of beginning; thence continuing North 02°-54'-52" West along said West line, a distance of 1,252.53 feet to the Northwest corner of said Southeast 1/4; thence South 87°-11'-55" East along the North line of said Southeast 1/4, a distance of 197.04 feet to the centerline of County Trunk Highway "VVV" (also known as Rolling Meadows Drive); thence South 49°-40'-50" East along said centerline, a distance of 1,143.06 feet; thence Southeasterly 714.04 feet along said centerline, on a curve to the right having a radius of 2,083.48 feet, the chord of said curve bears South 39°-51'-46" East, a chord distance of 710.55 feet to the Easterly extension of the Northerly line of said former railroad right-of-way (Mascoutin Valley Recreation Trail); thence North 88°-17'-02" West along said Northerly line, a distance of 1,460.73 feet to the point of beginning and containing 25.61 acres of land more or less.

Section 2. Effect of Annexation. From and after the date of adoption of this Ordinance, the property described in Section 1 hereof shall be part of the City of Fond du Lac for any and all purposes provided by law, and all persons coming or residing within such property shall be subject to all ordinances, rules and regulations governing the City of Fond du Lac.

Section 3. Ward Designation. The property described in Section 1 is hereby designated and made a part of Ward 30 and the poll location for Ward 30 is Masonic Center, 500 W. Arndt Street, Fond du Lac, Wisconsin.

<u>Section 4</u>. <u>Effective Date</u>. This Ordinance shall take effect and be in force upon its passage as provided by law.
