ORDINANCE NO. 2018-02

AN ORDINANCE ANNEXING TERRITORY FROM THE TOWN OF POUND TO THE VILLAGE OF COLEMAN, MARINETTE COUNTY, WISCONSIN

Property Owners: Bieber Investments, LLC and B & D Dairy Farm LLC

WHEREAS, a Petition has been filed with the Clerk of the Village of Coleman requesting the annexation of the hereinafter described territory heretofore located in the Town of Pound, Marinette County, Wisconsin to the Village of Coleman, Marinette County, Wisconsin, pursuant to Section 66.0217(2), Wis. Stats; and

WHEREAS, such matter was referred to the Village Board for review, the Village Board recommending such approval, and finding that the territory is contiguous and that the annexation is not contrary to the public interest; and

WHEREAS, the Village Board finds that the hereinafter described territory is contiguous to the Village of Coleman, that the Petition for Annexation herein is a Petition for direct annexation filed pursuant to Section 66.0217(2), Wis. Stats., that the Petitioners constitute the owners of all real property in such territory and that there are zero (0) electors residing within such territory, that the procedural requirements of Section 66.0217, Wis. Stats., have been complied with, the Village Board specifically finds that such annexation is not against the public interest.

NOW, THEREFORE, the Village Board of the Village of Coleman, Wisconsin, does ordain as follows:

SECTION 1. That the Village Board accepts such Petition for Annexation, thereby ordaining that the following described territory presently in the Town of Pound, Marinette County, Wisconsin, to wit:

See attached Exhibit A.

Tax Parcel No.: 028-00305.002 and 028-00296.004 owned by Bieber Investments, LLC and 028-00315.001 and 028-00316.000 owned by B & D Dairy Farm LLC

be and the same is hereby annexed to and made part of the Village of Coleman, Marinette County, Wisconsin. This annexation includes the right of way along Double R Road. Attached hereto, and identified as Exhibit A, is a legal description and scale map of the territory annexed herein.

SECTION 2. All such annexed territory shall be a part of the Village of Coleman for any and all purposes provided by law, and shall be subject to the laws, ordinances, rules and regulations of the Village of Coleman applicable thereto.

SECTION 3. That the above-described annexed property prior to annexation was part of the Coleman School District and such territory shall remain part of said School District.

SECTION 4. Upon recommendation of the Village Board, the territory annexed by the Village of Coleman by means of this Ordinance is hereby designated to be B-1 for the property owned by Bieber Investments LLC and I-1 for the property owned by B & D Dairy Farm LLC.

SECTION 5. That upon adoption of this Ordinance, the Clerk shall file a certified copy of this Ordinance, a Certificate of Annexation, and a scale map of the property annexed with the Secretary of State, with any utility company currently providing services to such area, with the Register of Deeds of Marinette County, and with the Clerk of the Coleman School District, in accordance with Section 66.0217(9). Wis. Stats., and, further, said Clerk shall give written notice of acceptance of such Petition for Annexation to the Clerk of the Town of Pound by personal service or by registered mail with return receipt requested.

SECTION 6. Pursuant to Wis. Stats. Section 66.0217 (14)(a)(1), the Village of Coleman agrees to pay annually to the Town of Pound, for 5 years, an amount equal to the amount of property taxes that the town levied on the annexed territory, as shown by the tax roll under s. 70.65, in the year which the annexation is final.

THIS ORDINANCE SHALL BECOME EFFECTIVE UPON ITS ADOPTION.

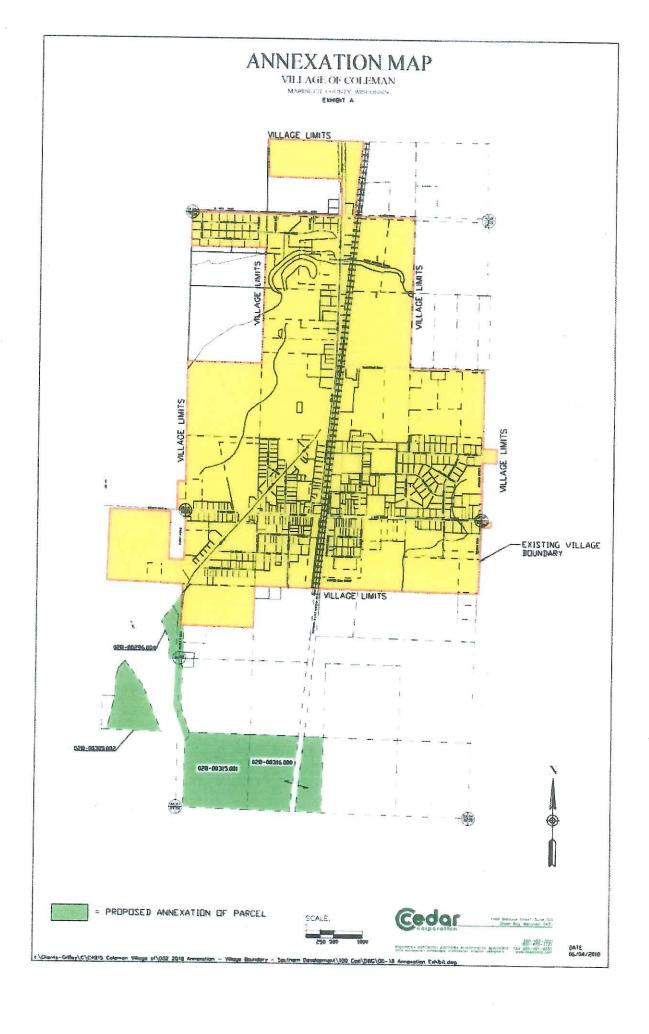

WHEREAS, a Petition has been filed with the Clerk of the Village of Coleman requesting the annexation of the hereinafter described territory heretofore located in the Town of Pound, Marinette County, Wisconsin to the Village of Coleman, Marinette County, Wisconsin, pursuant to Section 66.0217(2), Wis. Stats; and

WHEREAS, such matter was referred to the Village Board for review, the Village Board recommending such approval, and finding that the territory is contiguous and that the annexation is not contrary to the public interest; and

WHEREAS, the Village Board finds that the hereinafter described territory is contiguous to the Village of Coleman, that the Petition for Annexation herein is a Petition for direct annexation filed pursuant to Section 66.0217(2), Wis. Stats., that the Petitioners constitute the owners of all real property in such territory and that there are zero (0) electors residing within such territory, that the procedural requirements of Section 66.0217, Wis. 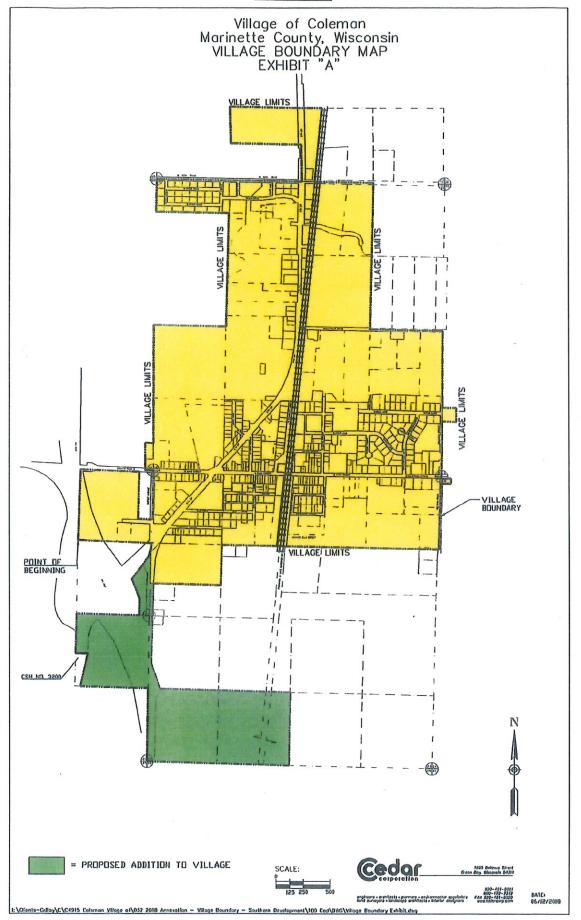
