

Ordinance No. 534

An Ordinance Annexing Territory to the City of Hayward, Sawyer County, Wisconsin

The common council of the City of Hayward does hereby ordain as follows:

Section 1: Territory Annexed.

In accordance with Section 66.0217 of the Wisconsin Statutes and the petition for direct annexation by unanimous approval filed with the City of Hayward Clerk on the 30th day of March 2018, signed by all the owners of all the real property located in the following described territory in the Town of Hayward, Sawyer County, Wisconsin is hereby annexed to the City of Hayward, Sawyer County, Wisconsin:

All that part of the Southeast Quarter of the Southeast Quarter (SE1/4SE1/4), Section Twenty-Two (22), Township Forty-one (41) North, Range Nine (9) West, located in the Town of Hayward, Sawyer County, Wisconsin, lying south of Davis Avenue and West of the following described parcel of property, more particularly described as follows:

A part of the Southeast ¼ of the Southeast ¼, Section 22, Township 41 North, Range 9 West, more particularly described as follows: Beginning at the Southwest corner of a parcel 435.05 feet East from the Southwest corner of the Southeast ¼ Southeast ¼; thence running variation North 86°10' East along the South line a distance of 87.01 feet; thence running variation North 5°07' West, a distance of 293.6 feet to the South right of way line STH 77; thence running variation North 65°34' West, along the right of way line a distance of 98.8 feet; thence running variation South 5°07' East along the West line a distance of 338.50 feet to the point of beginning.

Residential-One (R-1)

Section 4: Ward Designation.

The territory described in Section 1 of this ordinance is hereby made a part of the Fourth Ward of the City of Hayward, subject to the ordinances, rules and regulations of the City of Hayward governing wards.

Section 5: Severability.

If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provisions or application.

Section 6: Payment to Town of Hayward.

Pursuant to Wisconsin Statute Section 66.02174(14), the common council of the City of Hayward agrees to pay annually to the Town of Hayward, for 5 years, an amount equal to the amount of property taxes that the Town of Hayward levied on the annexed territory, as shown by the tax roll under Wisconsin Section 70.65 in 2018.

Section 7: Effective Date.

This ordinance shall take effect upon passage and publication as provided by law.
