AN ORDINANCE ANNEXING PROPERTY TO THE CITY OF FOND DU LAC AND CHANGE LIMITS TO INCLUDE UNDEVELOPED PROPERTY IN THE AREA OF WILLOW LAWN ROAD

The City Council of the City of Fond du Lac, Wisconsin, do ordain as follows:

Section 1. Property Annexed. In accordance with Section 66.0217 is. Stats., the following described territory, is hereby annexed to the City of Fond du Lac:

Lot 1 of Certified Survey Map No. 8145, recorded in the Fond du Lac County Register of Deeds Office in Volume 61 of Certified Survey Maps on Pages 57, 57A and 57B as Document Number 1075420 and that portion of Willow Lawn Road as dedicated on said Certified Survey Map lying directly north of said Lot 1, south of the North line of the Southwest 1/4 of Section 28, east of the West line of said Southwest 1/4 and west of the Westerly line of the former Chicago and Northwestern Railroad right-of-way (Wild Goose State Trail), located in the Northwest 1/4 of the Southwest 1/4 of Section 28, Township 15 North, Range 17 East, Town of Fond du Lac, Fond du Lac County, Wisconsin and containing 22.85 acres of land more or less.

<u>Section 2</u>. <u>Effect of Annexation</u>. From and after the date of adoption of this Ordinance, the property described in Section 1 hereof shall be part of the City of Fond du Lac for any and all purposes provided by law, and all persons coming or residing within such property shall be subject to all ordinances, rules and regulations governing the City of Fond du Lac.



Legal Description of Lands to be annexed

Lot 1 of Certified Survey Map No. 8145, recorded in the Fond du Lac County Register of Deeds Office in Volume 61 of Certified Survey Maps on Pages 57, 57A and 57B as Document Number 1075420 and that portion of Willow Lawn Road as dedicated on said Certified Survey Map lying directly north of said Lot 1, south of the North line of the Southwest 1/4 of Section 28, east of the West line of said Southwest 1/4 and west of the Westerly line of the former Chicago and Northwestern Railroad right-of-way (Wild Goose State Trail), located in the Northwest 1/4 of the Southwest 1/4 of Section 28, Township 15 North, Range 17 East, Town of Fond du Lac, Fond du Lac County, Wisconsin being more particularly described as follows:

Beginning at the Northwest corner of the Southwest 1/4 of said Section 28; thence South 89°-43′-52″ East along the North line of said Southwest 1/4, said line also being the current City of Fond du Lac corporate limit line, a distance of 1,299.25 feet to the Westerly line of said former Railroad right-of-way; thence Southwesterly 244.62 feet along said Westerly line on a curve to the right having a radius of 8,540.89 feet, the chord of said curve bears South 36°-06′-30″ West, a chord distance of 244.62 feet; thence South 22°-06′-25″ West along said Westerly line, a distance of 155.15 feet; thence Southwesterly 542.38 feet along said Westerly line on a curve to the right having a radius of 8,581.89 feet, the chord of said curve bears South 39°-44′-27″ West, a chord distance of 542.29 feet; thence South 42°-11′-57″ West along said Westerly line, a distance of 467.73 feet to the North right-of-way line of U.S. Highway "151"; thence North 83°-55′-50″ West along said North line, a distance of 447.24 feet to the West line of said Southwest 1/4; thence North 00°-28′-49″ East along said West line, a distance of 1,063.71 feet to the point of beginning and containing 22.85 acres of land more or less.
