ORDINANCE NO. 3682

AN ORDINANCE ANNEXING PROPERTY TO THE CITY OF FOND DU LAC AND CHANGE LIMITS TO INCLUDE IN THE AREA OF THE FOND DU LAC AIRPORT

The City Council of the City of Fond du Lac do ordain as follows:

Section 1. Property Annexed. In accordance with Wisconsin Statutes Section 66.0217 and a Petition for Direct Annexation filed with the City Clerk's office signed by all of the electors residing in the territory proposed to be annexed and the owners of all of the real property in the territory proposed to be annexed, the following described territory, which is contiguous to the City of Fond du Lac, Fond du Lac County, Wisconsin, is hereby annexed to the City of Fond du Lac:

Section 2. The annexation complies with the Cooperative Plan adopted under Wisconsin Statutes Section 66.0307 between the City of Fond du Lac and Towns of Byron, Empire, Fond du Lac, Taycheedah and Friendship in Fond du Lac County and approved by the Wisconsin Department of Administration on July 27, 2017.

<u>Section 3</u>. <u>Effect of Annexation</u>. From and after the date of adoption of this Ordinance, the property described in Section 1 hereof shall be part of the City of Fond du Lac for any and all purposes provided by law, and all persons coming or residing within such property shall be subject to all ordinances, rules and regulations governing the City of Fond du Lac.

<u>Section 4</u>. <u>Ward Designation</u>. The property described in Section 1 is hereby designated and made a part of Ward 3 and the poll location for Ward 3 is Evans Elementary School, 140 South Peters Avenue, Fond du Lac, Wisconsin.

<u>Section 5</u>. <u>Effective Date</u>. This Ordinance shall take effect and be in force upon its passage as provided by law.

EXHIBIT B

Annexation Description:

A parcel of land being a part of the Northeast Quarter of the Southeast Quarter of Section 17, T15N, R17E, Town of Fond Du Lac, Fond Du Lac County, Wisconsin.

Commencing at the East Quarter Corner of said Section 17;

Thence N88°13'01"W coincident with the North line of the Northeast Quarter of the Southeast Quarter of said Section 17 a distance of 371.92 feet to the East property line of the Fond Du Lac County Airport;

Thence S00°30′13″E coincident with said East property line a distance of 233.31 feet being the South line of the corporate limits of the City of Fond Du Lac also being the point of beginning of this description.

Thence continuing S00°30′13″E coincident with the East property line of the Fond Du Lac County Airport a distance of 30.00 feet;

Thence S89°55′29″W a distance of 510.66 feet to the Easterly line of the North – South Taxiway at the Fond Du Lac County Airport;

Thence N00°02'24"E coincident with said Easterly line a distance of 30.00 feet to the South line of the corporate limits of the City of Fond Du Lac;

Thence N89°55′29″E coincident with said South corporate limits line a distance of 510.38 feet to the point of beginning.


Said parceled land for Annexation purposes contains 0.35 acres (15,315 sq. ft.) more or less.
