ORDINANCE NO. 19-07 VILLAGE OF OREGON

AN ORDINANCE PROVIDING FOR A BOUNDARY CHANGE PURSUANT TO AN INTERGOVERNMETNAL AGREEMENT BETWEEN THE VILLAGE OF OREGON AND THE TOWN OF OREGON

RECITALS

- A. On August 5, 2019, the Village Board of the Village of Oregon adopted a resolution approving an agreement providing for the boundary change described on Exhibit A, pursuant to Wis. Stat. § 66.0301(6).
- B. On September 3, 2019, the Town Board of the Town of Oregon adopted a resolution approving an agreement providing for the boundary change described in Exhibit A, pursuant to Wis. Stat. § 66.0301(6).

NOW, THEREFORE, the Village Board of the Village of Oregon, Dane County, Wisconsin, does ordain as follows:

ORDINANCE

- 1. <u>Boundary Change</u>. In accordance with Wis. Stat. § 66.0301(6)(e), the Village Board hereby approves the boundary change described in Exhibit A.
- 2. <u>Effect of Boundary Change</u>. From and after the effective date of this ordinance, the territory added to the Village on Exhibit A shall be a part of the Village of Oregon for any and all purposes provided by law, and all persons coming or residing within such Territory shall be subject to all ordinances, rules, and regulations governing the Village of Oregon.
- 3. <u>Ward Designation</u>. The Territory shall be part of a Ward Nos. seven (7) and nine (9) in the Village of Oregon.
- 4. <u>Clerk Duties</u>. The Village Clerk is hereby directed to notice and provide copies of this ordinance pursuant to the applicable Wisconsin Statutes.
- 5. <u>Effective Date.</u> This ordinance shall take effect upon passage and publication pursuant to law.
