ORDINANCE NO. 7410

ORDINANCE ANNEXING TERRITORY TO THE CITY OF EAU CLAIRE.

THE CITY COUNCIL OF THE CITY OF EAU CLAIRE DOES ORDAIN AS FOLLOWS:

<u>Section 1</u>. <u>Territory Annexed</u>. In accordance with Section 66.0217 of the Wisconsin Statutes, the following described territory in the Town of Washington, Eau Claire County, Wisconsin, is annexed to the City of Eau Claire, Wisconsin.

WURZER BUILDERS ANNEXATION (Petition #14361) Town of Washington

Being all of the Southeast 1/4 of the Southeast 1/4, Section 2, Township 26 North, Range 9 West, Town of Washington, Eau Claire County, Wisconsin

Being all of the Southwest 1/4 of the Southwest 1/4, Section 1, Township 26 North, Range 9 West, Town of Washington, Eau Claire County, Wisconsin,

Including the South 66 feet of Lot 1, Certified Survey Map Number 148, recorded in Volume 1 of Certified Survey Maps, Page 180

Except all of Lots 1 and 2 Certified Survey Map Number 148, recorded in Volume 1 of Certified Survey Maps, Page 180, excluding the South 66 feet of said Lot 1.

Being more particularly described as follows:

Beginning at the East 1/4 corner of said Section 2;

Thence S02°18'49"W along the east line of the Northeast 1/4 of the Southeast 1/4 of said Section 2, 1332.85 feet to the Northeast corner of the Southeast 1/4 of the Southeast 1/4 of said Section 2 and the point of beginning;

Thence S88°22'29"E, along the south line of the Southwest 1/4 of the Southwest 1/4 of said Section 1, 1359.39 feet to the Southeast corner of said Southwest 1/4 of the Southwest 1/4 of Section 1;

Thence N01°57'25"E, along the east line of said Southwest 1/4 of the Southwest 1/4, 389.14 feet to a point on the extension of the south line of Lot 2 of Certified Survey Map Number 148, recorded in Volume 1 of Certified Survey Maps, Page 180, Document Number 488510; Thence N87°57'05"W, along the south line of said Lot 2 and its extension, 754.50 feet to the southwest corner of said Lot 2;

Thence N01°00'55"E, along the west line of said Lot 2, 300.00 feet, to the northwest corner of said Lot 2;

Thence S87°57'05"E, along the north line of said Lot 2 and its extension, 759.43 feet to the east line of said Southwest 1/4 of the Southwest 1/4 of Section 1;

Current population of such territory is seven (7).

Section 2. Effect of Annexation. From and after the date of this ordinance, the territory described in Section 1 shall be part of the City of Eau Claire for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of Eau Claire.

Section 3. Temporary Zoning Classification. The territory annexed to the City of Eau Claire by this ordinance is temporarily designated to be R-1A -- Non-Sewered One-Family Dwelling District for zoning purposes and subject to all provisions of the zoning ordinance of the City of Eau Claire relating to such district classification and to zoning in the city.

Section 4. Ward Designation. The territory described in Section 1 of this ordinance is hereby made a part of the 38th Assessment Ward and the 2nd Aldermanic District of the City of Eau Claire, subject to all ordinances, rules and regulations of the city governing wards and districts.

Section 5. Severability. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstance is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or application of this ordinance which can be given effect without the invalid or unconstitutional provisions or applications.
