ORDINANCE NO. 461
ORDINANCE OF DIRECT ANNEXATION BY UNANIMOUS APPROVAL

THE VILLAGE BOARD OF THE VILLAGE OF CASHTON, MONROE COUNTY, WISCONSIN, DO ORDAIN AS FOLLOWS:

Section 1. Pursuant to Section 66.021(12), Wis. Stats., a petition for direct annexation signed by all of the electors residing in and the owners of all real property in the territory described below has been filed with the Village Clerk and with the Town Clerk of the town of Portland in which such territory is located, together with a scale map and description of the property to be annexed showing boundaries of such territory and the relationship of the territory to the municipalities, and a copy of such petition, map and description of the territory was mailed to the Department of Development within five days after filing, the advice of the department having been reviewed by the Village Board.

Section 2. The following described territory located in Monroe County, Wisconsin is hereby annexed to the Village of Cashton, Monroe County, Wisconsin, to- wit:

Said property is described on Exhibit A which by references is incorporated herein.

Section 3. The territory annexed by this ordinance shall be temporarily designated as industrial for zoning purposes under the Village of Cashton zoning

Section 4. The Village Clerk shall file immediately with the Secretary of State a certified copy of this ordinance, and a copy with the Register of Deeds, signed by the City Clerk, describing the territory which was annexed, all pursuant to Section 66.021(8), Wis. Stats.

Section 5. This ordinance shall be in full force and effect following its enactment by a two-thirds vote of the elected members of the governing body of the Village of Cashton.

## VILLAGE OF CASHTON AMMEXATION



Railroad; thence Southwesterly along said Right-of-Way 587.00 feet more or less to the Northerly Right-of-Way of Eureka Avenue; thence Northwesterly along the Northerly Right-of-Way of Eureka Avenue to the Easterly Right-of-Way of S.T.H. "27 "; thence Westerly to a point on the Westerly Right-of-Way of S.T.H. "27 " at the Southwest corner of that land described in Volume 84 of Misc, Page 116; thence Northerly along the West Line of that land described in Volume 84 of Misc. Page 116 to the North line of said Section Thirty Six ( 36 ); thence North 89° 40' 23" West along said North line 802.90 feet to the North One-Quarter corner of said Section Thirty Six ( 36 ); thence South 0° 19' 13" West along the East line of the Northwest One-Quarter of the Northeast One-Quarter (NWW-NEW) of said Section Thirty Six ( 36 ) 1,124.90 feet; thence East 422.51 feet to the Westerly Right-of-Way of S.T.H. "27 "; thence North 40° 07' 34" East along said Right-of-Way 292.42 feet; thence North 55° 26' West 157.00 feet; thence North 34° 34' East 177.00 feet; thence South 55° 26' East 157.00 feet to the Westerly Right-of-Way of S.T.H. "27 "; thence North Easterly Right-of-Way of S.T.H. "27 "; thence










