


CERTIFICATE OF ANNEXATION

ORDINANCE OF THE COMMON COUNCIL

AN ORDINANCE PROVIDING FOR THE DIRECT ANNEXATION BY UNANIMOUS APPROVAL OF A PORTION OF THE TOWN OF RUTLAND TO THE CITY OF STOUGHTON, DANE COUNTY, WISCONSIN

RECITALS

- Kettle Park West LLC ("Owner") owns land in the Town of Rutland as described in Exhibit A and shown in Exhibit B (the "Territory") and is seeking to annex the Territory (part of parcel #052/0510-013-8385-0) by unanimous approval to the City of Stoughton, pursuant to Wis. Stat. § 66.0217(2).
- B. The City of Stoughton Plan Commission has recommended that the Territory be annexed to the City, and that the Territory be assigned a zoning classification of I Institutional (Park).
- C. The proposed annexation has been reviewed by the Wisconsin Department of Administration (MBR #14357) to and has been determined to be in the public interest.
- D. The population of the annexation area is 0.
- E. The annexation represents approximately 4.010 acres from the Town of Rutland.

NOW, THEREFORE, the Common Council of the City of Stoughton, Dane County, Wisconsin, does ordain as follows:

ORDINANCE

- 1. <u>Recitals</u>. The above recitals are material to and are incorporated in this Ordinance.
- 2. <u>Territory Annexed</u>. The Territory is annexed to the City of Stoughton pursuant to Wis. Stat. § 66.0217(2).
- 3. <u>Effect of Annexation</u>. From and after the effective date of this ordinance, the Territory shall be a part of the City of Stoughton for any and all purposes provided by law, and all persons coming or residing within such Territory shall be subject to all ordinances, rules, and regulations governing the City of Stoughton.

- 4. <u>Zoning Designation</u>. The Territory shall be zoned I Institutional (Park).
- 5. <u>Ward Designation</u>. The Territory shall be added to <u>Ward No. 9</u> of the City of Stoughton.
- 6. <u>Clerk Duties</u>. The City Clerk is hereby directed to publish notice of and provide copies of this Ordinance in accordance with the applicable Wisconsin Statutes.
- 7. <u>Effective Date</u>. This ordinance shall take effect upon passage and publication as provided by law.


PARKLAND DEDICATION Legal Description

Part of the Northeast Quarter of the Southwest Quarter of Section 01, Township 05 North, Range 10 East, Town of Rutland, Dane County, Wisconsin, more particularly described as follows:

Commencing at the South Quarter corner of Section 01, aforesaid; thence North 00 degrees 04 minutes 33 seconds West along the East line of the Southwest Quarter, aforesaid, 1320.87 feet to the Southeast corner of the Northeast Quarter of the Southwest Quarter, also being the Point of Beginning; thence North 87 degrees 05 minutes 33 seconds West along the South line of the Northeast Quarter of the Southwest Quarter of the Southwest Quarter of the Northeast Quarter of the Southwest Quarter of Section 01, aforesaid, 521.10 feet; thence North 00 degrees 04 minutes 33 seconds West, 337.39 feet; thence South 86 degrees 42 minutes 21 seconds East, 521.30 feet to the East line of the Southwest Quarter of Section 01, aforesaid; thence South 00 degrees 04 minutes 33 seconds East along said line, 333.87 feet to the Point of Beginning.

Containing 174,661 square feet or 4.010 acres.
