Section 66.0217 (l4)(a)(l), the Village of Wrightstown agrees to pay annually to the Town of Wrightstown, for five (5) years, an amount equal to the amount of property taxes that the Town levied on the annexed territory, as shown by the tax roll under s.70.65, in the year which the annexation is final.
