ORDINANCE NO. 22-01028

ORDINANCE ANNEXING TERRITORY TO THE CITY OF OCONOMOWOC, WISCONSIN (ROBERT MILLER LANDS OCOT 0517.996.005 & OCOT 0520.999.004)

The Common Council of the City of Oconomowoc, Waukesha County, Wisconsin, do ordain as follows:

SECTION 1. TERRITORY ANNEXED (DIRECT ANNEXATION). In accordance with §66.0217, Wis. Stats., and the petition for direct annexation filed with the City Clerk on January 14, 2022, signed by the all the electors residing in the territory (of which there were none) and the owners of all of the real property in the territory, the following described territory in the Town of Oconomowoc, Waukesha County, Wisconsin, is annexed to the City of Oconomowoc, Wisconsin.

SEE ATTACHED LEGAL DESCRIPTION AND MAP

- **SECTION 2. EFFECT OF ANNEXATION.** From and after the date of this ordinance, the territory described in Section 1 shall be a part of the City of Oconomowoc for any and all purposes provided by law, and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of Oconomowoc.
- **SECTION 3.** WARD AND ALDERMANIC DISTRICT DESIGNATION. The territory described in Section 1 of this ordinance is hereby made part of Ward 1, First Aldermanic District of the City of Oconomowoc, subject to the ordinances, rules and regulations of the City governing wards and aldermanic districts.
 - **SECTION 4. POPULATION.** The current population is zero.

SECTION 5. TEMPORARY ZONING CLASSIFICATION.

- A. Upon recommendation of the Plan Commission, the territory annexed to the City of Oconomowoc by this ordinance is temporarily zoned as follows, pursuant to §66.0217(8), Wis. Stats.: Urban Reserve (UR).
- B. The Plan Commission is directed to prepare an amendment to the zoning ordinance setting forth a permanent classification and regulation for the zoning of the annexed area and to submit its recommendation to the Common Council within one hundred twenty (120) days of the effective date of this ordinance.

SECTION 6. SEVERABILITY. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.

SECTION 7. EFFECTIVE DATE. This ordinance shall become effective upon passage and publication as provided by law.


