# AN ORDINANCE TO DETACH AND ATTACH TERRITORY BY AND BETWEEN THE TOWN OF LISBON TO THE VILLAGE OF SUSSEX IN ACCORDANCE WITH SECTION 66.0307 OF THE WISCONSIN STATUTES

**WHEREAS**, the Village of Sussex ("Sussex") and the Town of Lisbon ("Lisbon") have entered a Cooperative Boundary Plan Agreement ("CBP") under Wisconsin statute §66.0307; and,

**WHEREAS**, the CBP provided for boundary changes between the municipalities as authorized by law; and

**WHEREAS**, §66.0307 provides that a boundary change under a cooperative plan shall be accomplished by the enactment of an ordinance by the governing body designated to do so in the plan; and

**WHEREAS**, boundary changes provided for in the plan will result in parcels being transferred from Lisbon to Sussex and from Sussex to Lisbon.

**NOW, THEREFORE, BE IT HEREBY ORDAINED** that the Village of Sussex detaches the parcels more particularly described on Exhibit A attached hereto and incorporated herein by reference to the Town of Lisbon and agrees to the attachment of the parcels more particularly described on Exhibit B attached hereto and incorporated herein by reference from the Town of Lisbon, effective immediately.

**FURTHER** the Village Clerk is directed to comply with the notice and filing requirements under Wisconsin statute §66.0307 (10.).






Village of Sussex / Town of Lisbon 2022 Boundary Agreement Attachment Map Key
