ORDINANCE NO. 808- 2022.6

AN ORDINANCE ANNEXING TERRITORY TO THE CITY OF GREEN LAKE

(Land Owned by Alex A. & Ann L. Zabel, Property at West End of Division Street, Green Lake, WI)

The Common Council of the City of Green Lake in a regular session duly begun on the 13th day of June, 2022, does ordain as follows:

WHEREAS, Alex A. & Ann L. Zabel has petitioned to annex their property at the west end of Division Street;

AND WHEREAS, the Plan Commission has reviewed and recommends approval of annexing said land.

NOW THEREFORE, be it ordained as follows:

SECTION 1: <u>Territory Annexed</u>. In accordance with Section 66.0217 (2) of the Wisconsin Statutes and the petition for direct annexation filed with the City Clerk signed by all of the owners of the real property and resident/electors, the following described territory in the Town of Brooklyn (Green Lake County, Wisconsin) is annexed to the City of Green Lake (Green Lake County, Wisconsin):

Being a part of the Northeast ¼ of the Northeast ¼ and part of the Southeast ¼ of the Northeast ¼ of Section 21, T16N, R13E, Town of Brooklyn, Green Lake County, Wisconsin, bounded and described as follows:

Commencing at the northeast corner of Section 21, T16N, R13E; thence S00°53'41"W, along the east line of the Northeast ¼ of said Section 21, 934.62 feet to the point of the beginning; thence S00°53'41"W, along the east line of the Northeast ¼ of said Section 21, 1109.95 feet to the north line of Lot 1 of Certified Survey Map No. 1170, as recorded in Volume 4 of Certified Survey Maps for Green Lake County, on Page 1170; thence S89°41'54"W, along the north line of said Lot 1, 165.66 feet to the east line of Certified Survey Map No. 34, as recorded in Volume 1 of Certified Survey Maps for Green Lake County, on Page 34; thence N00°50'38"E, along the east line of said Certified Survey Map No. 34 and along the east line of Lot 1 of Certified Survey Map No. 1083, as recorded in Volume 4 of Certified Survey Maps for Green Lake County on Page 1083, 1111.90 feet; thence S89°37'28"E, 166.62 feet to the point of the beginning.

Said parcel contains 4.237 acres, more or less. Parcel subject to easements, restrictions and reservations in use or of record.

SECTION 2: <u>Effect of annexation</u>. From and after the date of this ordinance the territory described in Section 1 shall be a part of the City of Green Lake for any and all

purposes provided by law and all persons coming on or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of Green Lake.

SECTION 3: <u>Schools</u>. The territory described in Section 1 is annexed for school purposes and is hereby made part of the Green Lake School District and subject to all laws governing the same.

SECTION 4: <u>Temporary Zoning Classification</u>. The territory annexed to the City of Green Lake by this ordinance is temporarily classified as Conservancy (CS).

SECTION 5: <u>Ward Designation</u>. The territory described in Section 1 of this ordinance is hereby made a part of the First Aldermanic District of the City of Green Lake, and is designated as part of Ward Number 4, subject to the ordinances, rules and regulations of the city governing wards.

SECTION 6: <u>Severability</u>. If any provisions of this ordinance are invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.

SECTION 7: <u>Population</u>. The population of this annexed territory is zero.

SECTION 8: <u>Annexation Payments</u>. The City Agrees to make the required payments pursuant to Section 66.0217(14) of the Wisconsin State Statutes.

SECTION 9: <u>Effective Date</u>. This ordinance shall take effect upon passage and publication as provided by law.




