# An Ordinance to Annex Property (2022 Cedar St.)

#### Ordinance 2022-01

The Village Board of the Village of Baldwin – St. Croix County, Wisconsin does hereby ordain as follows:

PURPOSE: The purpose of this Ordinance is for the Village of Baldwin to annex the listed property into the Village of Baldwin from the Town of Hammond.

#### Section 1 – TERRITORY ANNEXED

That pursuant to Sec. 66.0223(1) of the Wisconsin Statutes, the following territory owned by the Village of Baldwin is hereby detached from the Town of Hammond, St. Croix County, Wisconsin and annexed to the Village of Baldwin.

## Section 2 - EFFECT OF ANNEXATION




