AN ORDINANCE ANNEXING TERRITORY TO THE CITY OF CLINTONVILLE FROM THE TOWN OF LARRABEE, WAUPACA COUNTY, WISCONSIN

Section One: Territory Annexed. Pursuant to the authority granted by Section 66.0217(2), Wis. Stats., the following described territory in the Town of Larrabee, Waupaca County, Wisconsin, is hereby annexed to the City of Clintonville:

(Exhibit A – Legal description and map). Available to view at City Hall or request copy.

Section Two: Effect of Annexation. From and after the date of this ordinance the territory described in section 1 shall be part of the City of Clintonville for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of Clintonville.

Section Three: Zoning Classification. Parcels shall be zoned R1 – Residential.

Section Four: Ward Designation. The territory described in Section One and Section Two of this ordinance is hereby made a part of the Ninth Ward, Supervisory District 4 of the First Aldermanic District of the City of Clintonville, subject to the ordinances, rules and regulations of the City of Clintonville governing wards and districts.



If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstance is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or application of this ordinance which can be affected without the invalid or unconstitutional provision or application.

Section Six: Effective Date. This ordinance shall take effect upon passage and publication.



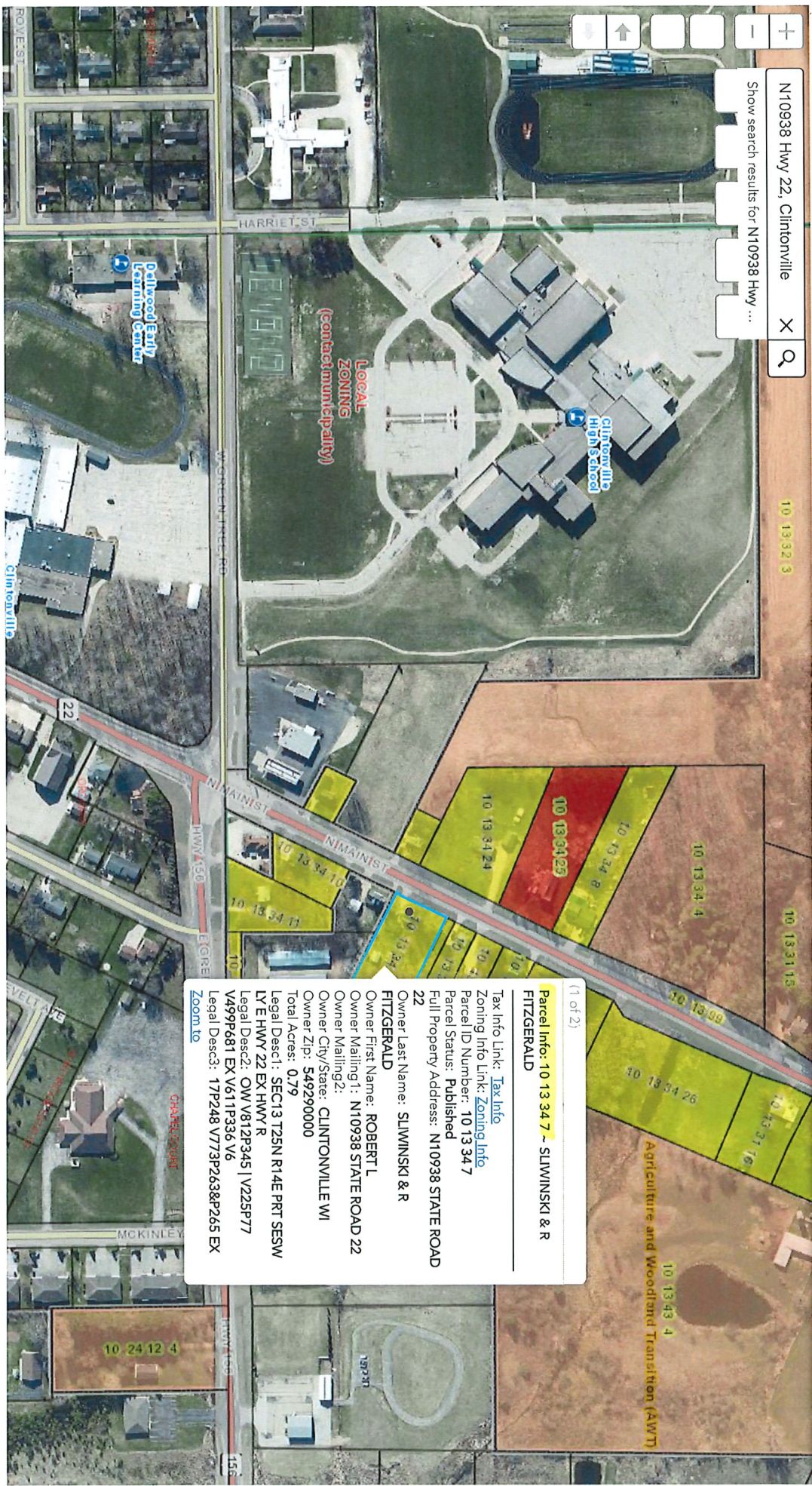
