

ORDINANCE NO. 23-1021

AN ORDINANCE ANNEXING THE HEREIN DESCRIBED PROPERTY TO THE CITY OF VERONA, DANE COUNTY, WISCONSIN

The Common Council of the City of Verona, Dane County, State of Wisconsin, by at least a two-thirds (2/3) vote of its members, does hereby ordain as follows:

Section 1. Territory Annexed.

In accordance with Section 66.0217 of the Wisconsin Statutes the following described territory contiguous to the City of Verona and located in the Town of Verona, Dane County, Wisconsin is hereby annexed to the City of Verona:

Legal descriptions as surveyed in the Town of Verona, Dane County, State of Wisconsin

LANDS TO BE ANNEXED TO THE CITY OF VERONA

All of Lot 1 and Lot 2, certified survey map 7393 (CSM 7393) recorded in volume 38 of certified survey maps on pages 63 and 64 as document 2583819 in the Dane County Register of Deeds office, and portions of County Highway "M", Located in the SE 1/4 of the SE 1/4 of Section 22, T6N, R8E, Town of Verona, Dane County, Wisconsin. Being more fully described as follows:

Commencing at the southeast corner (SE) of said Section 22;

Thence N00°01'47"W, 364.95 feet along the east line of the southeast quarter (SE1/4) to the northerly existing right of way line of USH 18, also being the point of beginning;

Thence S74°03'41"W, 170.61 feet along said northerly right of way line of USH 18 to the easterly existing right of way line of CTH M;

Thence S85°27'28"W, 420.50 feet along said northerly right of way line of USH 18 to the westerly existing right of way line CTH M;

Thence N33°47'51"E, 217.01 feet along said westerly right of way line of CTH M to the centerline of CTH M;

Thence 388.46 feet on the centerline CTH M and along the arc of a curve to the right having a radius of 1272.50 feet, a delta angle of 17°29'28", a chord bearing of N30° 13' 45"W, and a chord length of 386.96 feet;

Thence N21°31'58"W, 93.66 feet along the centerline of CTH M;

Thence S88°39'49"E, 146.52 feet to the easterly right of way of CTH M;

Thence continuing S88°39'49"E, 101.89 feet;

Thence S28°27'28"E, 241.86 feet;

Thence S88°40'27"E 328.06 feet to the east line of the southeast quarter (SE1/4) of Section 22;

Thence S00°01'47"E, 295.63 feet along the east line of the SE1/4 to the point of beginning.

Said parcel of land contains 5.54 acres (241,223 square feet) more or less.

Said parcel is contiguous to the City of Verona, subject to any and all easements and/or right-of-ways of record. Said parcel contains zero (0) electors and has a population of zero (0).

Section 2. Effect of Annexation.

From and after the date of this Ordinance, the territory described in Section 1 shall be a part of the City of Verona, Dane County, Wisconsin for any and all purposes provided by law and all persons coming to or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of Verona. Per Chap. 66.0217(14)(a)1 the City of Verona agrees to pay annually to the Town of Verona, for five (5) years, an amount equal to the amount of property taxes that the Town of Verona levied on the annexed territory, as shown on the tax roll under s. 70.65, in the year in which the annexation is final.

Section 3. Temporary Zoning Classification.

Upon recommendation by the Plan Commission, the territory annexed to the City of Verona by this Ordinance is temporarily designated to be a part of the following district of the City for zoning purposes and subject to all provisions of the zoning ordinance of the City of Verona relating to such district classification and to zoning in the City: Rural Agriculture.

Section 4. Voting Districts.

The territory annexed east of County Highway M shall be within the following voting districts:

- (a) Aldermanic District No. 4
- (b) Ward No. 11
- (c) Dane County Supervisory District No. 32

Section 5. Severability.

If any provision of this Ordinance is invalid or unconstitutional, or if the application of this Ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this Ordinance which can be given effect without the invalid or unconstitutional provision or application.

Section 6. Effective Date.

This Ordinance shall be effective and the territory described in Section 1 shall be considered annexed to the City of Verona upon publication as required by law and upon execution of an annexation agreement.




